INVITATION TO PARTICIPATE 2018

College Town Hockey is proud to announce that it will be hosting its' **21st Annual Labor Day Face Off Tournament** August 31st -September 2nd, 2018 at Marlboro, Foxboro, Walpole, Attleboro and Bridgewater.

The Face Off Tournament will have five Age Divisions: Midget Major (18U), Midget Minor (16U), Midget 15U, Bantam Major (2004), and Bantam Minor (2005) consisting of 3 Levels for each (Elite, Tier 1, & Tier 2). There will be separate playoffs for each Division with a Champion being crowned in each one.

All teams will be guaranteed four games within their bracket. **Please be prepared to start playing games on Friday August 31st at 8:00am.** All teams will play two games Friday and two games Saturday. All playoff games will be played on Sunday. The first four games will consist of **two 22.5 minute stop-time periods.** There will be overtime and shootout if necessary in the playoff rounds. NOTE: If the score difference is (6) goals or more at any time during the second period, the clock goes to running time. If the goal differential drops to five or less, stop time will then be re-implemented. All games played to a conclusion. A two man officiating system will be used for all games utilizing top officials in the region assigned by Geno Binda. There will be medical staff at all rinks. Real time updates of games will be posted on the website www.tier1faceoff.com

The Massachusetts/USA Hockey tournament rules will apply with a firm no fighting policy strictly enforced.

Cost for the tournament is \$1800.00 with a non-refundable deposit of \$900 due with team application to reserve your spot. Teams not accepted will have their checks returned. You may pay by credit card through the website www.tier1faceoff.com

Teams participating in the tournament MUST use our host hotels as they are very loyal partners and sponsors of the tournament. Failure to do so may result in your association being disqualified from the tournament and/or forfeiting consideration in future tournaments. You may stay at the hotel of choice as long as it is one of the partnered hotels listed on the website at www.tier1faceoff.com

Team rosters must be submitted no later than July 15, 2018 to appear in the program book. **All teams MUST submit an official USA Hockey roster by August 15, 2018.** A mailing with player names is delivered to all Division I, II/III colleges and prep schools in the New England and New York area. The tournament is highly attended by their coaching staffs. This is the most prestigious tournament in the northeast. Each year many of the participating teams have advanced to the USA Hockey National Championships. This tournament fills up fast. Please do not hesitate to contact us with any questions.
