"Came to believe that a power greater than ourselves could restore us to sanity."

She said: In July 1519 when the Spanish explorer Cortez landed at Veracruz, the first thing he did was burn his ships. mustered the troops and told them they had two choices; to forge ahead or to perish on the beach. Burning the ships removed a third alternative, giving up and returning to Spain. Take a minute to envision a broken down conquistador in the shadow of his egomaniacal "leader" watching those ships burn, cutting him off from the only way of life he had ever known, and you can begin to get in touch with a Second Step moment in the life of an alcoholic. We can all relate to being "crushed by a self-imposed crisis we could neither postpone nor evade." We too were left standing outside the borders of sanity with little else but the tyrannical force that drove us there. In the fading firelight from the incineration of his former life, the alcoholic realizes that he is powerless to escape this dilemma of his own volition.

I endured a terrific thrashing at the hands of "John Barleycorn," but my intellectual pride and ego are what really beat me into a state of submission. I continued to flail until I BEGAN to experience the ego collapse process that precedes a conversion experience. I swaggered into my first few meetings, life in shambles and court card in hand; convinced I knew what was going on through my veil of bogus perceptions. I notified my infinitely patient sponsor that I was alert and wary regarding the religious brainwashing that might ensue. A roving, postmeeting pack of women overheard my maudlin comment, and set upon me like an aberrant Greek chorus in my own private theatre of the absurd. A gang of recovering women can be fairly intimidating anywhere, but these were New Yorkers, and most of them were as subtle as defensive linemen. They did not shield me from their remarks or attempt to obscure the fact that they had patently eavesdropped (cont. p 2)



He said: The Second Step has two parts; 1.) Seeing the insanity in our own

lives, and 2) Believing (or even being willing to believe) that God can take away this insanity. A good definition of insanity is: doing the same thing over and over and expecting different results.

Five years ago I was insane and I had known it for a while. I could see the wreckage that alcohol and drugs were creating in my life and I could not make it stop. I was in pain, twisted up in my own thoughts and stagnated with fear. AA found me on May 14<sup>th</sup> 2005. I started going to meetings and fellowshipping after the meetings. Soon, I found a sponsor I liked and started going over to his house weekly to work the Steps.

In preparing its readers for the Second Step our AA textbook, 'The Big Book', gives lots of examples of alcoholic insanity. From 'Bill's Story' to 'Jim, Fred, and the Jay-walker', the Big Book authors are trying to help us see the insanity in our own lives by sharing the stories of others. When you honestly look back on your own life, if you can see none of this insanity then you are probably not ready for AA. You should enjoy your life like a normal non-alcoholic person and not worry about AA or the Steps. Come back later when you are ready. If you *can* relate then please read on...

The next part of this Step is to believe that God CAN take away our insanity. Actually, we don't even need to believe. We only need to be willing to believe. Check it: Page 47 in the Big Book, We needed to ask ourselves but one short question. "Do I now believe, or am I even willing to believe, that there is a power greater than myself?" We don't need to believe all the way at once. The Big Book says that once we are even willing to believe we commence to get results.

**My advice for** anyone looking for a Higher Power is to just try it out and see if it works. How do we (cont. p2)





on a private conversation. "Listen to THIS one! She just fell off a hearse and now she's got conditions!" The group erupted in laughter. "Oh yeah, now she wants to dictate terms!" I shifted uncomfortably in my combat boots, regretting that I had openly discussed writing an expose on the cult of AA. "I'm simply stating for the record with the honesty you all seem to get such a kick out of, that I am on my guard that this may be a sophisticated attempt at brainwashing." That statement sent them into complete hysterics. "Oh my God! There's nothing 'sophisticated' about it, honey, but good thing you're on your guard!!" As I blushed I tried hard to concentrate only on the fact that in her Brooklynese accent "God" and "guard" were indistinguishable. When the laughter faded and they moved off, my sponsor promptly hugged me. I thought my mortification was complete and my reaction was to raise my hackles, but just when I thought it couldn't get any worse, it did. My sponsor lovingly looked me in the eye and said just above a whisper, "Sweetie, I hope you hang around here long enough to see just how thoroughly your brain NEEDS washing." I got a paranoid glimmer she could see right into me, my thoughts flashing across my forehead like one of those "scores across the league" ticker tapes at the bottom of Giants games. I broke away as quickly as I could so she couldn't read my thought tape which was, "Boy, this one's in DEEP." What I didn't find out until much later is that she was thinking the same exact thing! I felt publicly and profoundly humiliated, furious, disoriented, and hopeless. Everything hurt. It hurt to be in daylight, it hurt to brush my hair, it hurt to think; basically, it hurt to be alive. Suddenly I couldn't cope with one more second. I burst out into some very loud and effusive tears. In that moment "I" broke, and Higher Power came through the wound. My contempt prior to investigation nearly killed me. I learned that to find truth one must be willing to let go of knowledge. The essence of Step Two is let go, or be dragged.

### A Newcomer Asks About:

### "The Promises"

You've heard them at nearly every meeting: The Promises. "If we are painstaking about this phase of our development..." is followed by the inevitable "WORK! WORK! WORK!" If you're anything like me you have probably muttered, "bulls\*\*t" under your breath at some point. But hold on a minute, perhaps you know this already but these promises are made upon completion of the Ninth Step. Are you there yet? Probably not. So let's go back a bit to page 52 of the Big Book. (Remember that one? You should read it at some point) Right about in the middle it says, "We were having trouble with our personal relationships, we couldn't control our emotional natures, we were prey to misery and depression, we couldn't make a living, we had a feeling of uselessness, we were full of fear, WE WERE UNHAPPY, we couldn't seem to be of any real help to other people...." These are "The Bedevilments" of alcoholism. Chances are that one, if not all of these Bedevilments, applies to you. Maybe your family has begged you to come here. Maybe your psychiatrist or doctor has. Maybe the way you made your living got you here, by boss or by judge. Maybe you were just unhappy and looking for a way out of the pain. Chances are if you're at a meeting, you've caught a case of The Bedevilments.

Now if we've gotten to page 52 of the Big Book then we already know "There is a Solution." Thousands of men and women have recovered. Not by reading, not by attending meetings, but by doing the Twelve Steps of Alcoholics Anonymous, usually with a sponsor, and always with Chapter Five, "How it Works," at hand. You may have gotten a taste of The Promises with a few weeks or months clean, but don't rest on your laurels! Work the Steps,

consistently and to the best of your ability and the rewards grow. Work them once with a sponsor, work them again with a newcomer, work little steps each day. Work the steps month by month with Daily Meditations. Work the steps with a group or at a workshop. The oldest (clean years) alcoholics I know are still working the steps with a sponsor and they are still learning. And more and more the Promises are coming true for them. If you cannot believe in the Promises yet, ask yourself if the Bedevilments apply to you. If even one has touched you, just for today believe the Promises will come to you. (IF you work for them).

## 12 Concepts for World Service

This was presented to Hawaii Area 17 at the Inform the Delegate assembly April 2006 by Francesca P (alternate delegate) and given as "an expression of an individual".

"Webster defines principle as a doctrine - A fundamental truth or doctrine, on which others are based- Rules of conduct or ethical behavior.

These concepts therefore aim to record the "why" of our service structure in such a fashion that the highly valuable experience of the past, and the lessons we have drawn from that experience, can never be forgotten or lost (p 3)."

## **Concept II** – Delegation

The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

Hence the principle of amply delegated authority and responsibility to "trusted servants" must be implicit from the top to the bottom of our active structure of service. (p 10)

No matter what authority the groups had, they could not meet their new responsibilities until they had actually delegated most of the active ones. It was precisely in order to meet this need that the General Service Conference of Alcoholics Anonymous was given the general responsibility for the maintenance of A.A.'s World Services and so became the service conscience for A.A. as a whole. (p 12)

Assembly in Waianae on January 16:
