#### **PUBLIC COMMENTS**

Sheriff Matt Sparks addressed the Commission with comments concerning the recent break-ins and attempted break-ins of vehicles in the City. He responded to questions from the Commission and those in attendance and gave the following recommendations:

- First and foremost....CALL 911 TO REPORT ANY INCIDENT.
- NEVER be a vigilante and try to confront the perpetrator.
- Keep your individual properties well lit by turning on outside lights or even having KU install a security light on your property.
- Always lock your homes and cars.
- Do not leave items in your car.....even a plain notebook can look like a tablet through a car window.
- Be on the lookout for suspicious activity, such as vehicles that appear out of place, persons on foot that are not familiar and are suspicious acting, anything out of the ordinary and call 911 to request assistance.
- Get license plate numbers.
- Keep a watch on your neighbors' property, especially if they are not home.
- Always report suspicious activity to the Sheriff's office by calling 911 or Kentucky State Police at 606 784-4127.
