

AMELIA VILLAGE, OHIO
Ordinance O-2013-31

AN ORDINANCE AMENDING O-2012-21, APPOINTING DANI SPIEGEL TO THE POSITION OF VILLAGE ZONING INSPECTOR AND DECLARING AN EMERGENCY.

WHEREAS, Dani Speigel was appointed Amelia Village Zoning Inspector by the adoption of O-2012-21 on April 24, 2012; and

WHEREAS, Village Council desires to increase the hours of the Zoning Inspector position, due to an increased workload;

NOW, THEREFORE, BE IT ORDAINED by Council of Amelia Village that:

SECTION I Dani Speigel is hereby appointed to the position of Village Zoning Inspector at an hourly rate of \$12.00 per hour, not to exceed 29 hours per week.

SECTION II Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION III That this Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village, and for the further reason that it is immediately necessary to increase the working hours of the Village Zoning Inspector to ensure that the Village Zoning Code is continuously administered and enforced. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

RENEE GERBER moved to suspend the rules requiring three readings on three separate dates.


