

# 39<sup>th</sup> ANNUAL COLORADO COUNTY FAIR PARADE SATURDAY, SEPTEMBER 9, 2017

We invite you to participate in the 39<sup>th</sup> Annual Colorado County Fair Parade on Saturday, September 9, 2017. Enclosed are the Entry and Disclaimer Forms which must be returned no later than Wednesday, September 6. The forms may be mailed to the address below, faxed to 979-732-2016 or 979-732-5881, or emailed to melissa-kilpatrick@sbcglobal.net (with a follow up call to 713-444-9059 to confirm receipt of the email).

Please note, due to insurance and safety standards, all-terrain vehicles (such as 4-wheelers and go-carts) will not be allowed. Also, no candy or toys, beads, koozies, etc. may be thrown from the parade vehicles/floats; however, you may have walkers alongside your entry handing out such treats to the children and spectators.

Categories for judging will include Antique Vehicle, Float, Equestrian, Commercial, Service Organization, Educational and Marching/Twirling. First, Second and Third Place rosettes will be awarded in each category, along with rosettes for Most Outstanding Overall Entry and Best Themed Entry. The **theme** of this year's parade is "**Cowboy Boots & Country Roots.**" Judging will take place as the parade participants wait in the line-up for the start of the parade. Vehicles of Elected Officials will not be judged. The parade will begin at 10:00 a.m.

#### PARADE DAY INFORMATION:

- 1. 8:00 8:45 AM—Have a representative from your parade entry come to the parade registration table located on Milam Street near the Elementary School Tennis Courts. You will be given an entry number so you can go to your place in the line-up.
- 2. Please line up closely behind the vehicle in front of you. BUT once the parade begins, leave plenty of space in between entries to give the announcer plenty of time to announce about each entry (see No. 4 below).
- 3. 8:45 9:00 AM—Be ready for judging with all participants present, in place and entry # posted on the entry and visible to the judges. Judging will begin at 9:00 AM.
- 4. 9:50 AM—Be ready to take off, have everyone in place and move along in line as the entry in front of you moves into the parade route. When you reach Jackson Street, please wait to proceed until the vehicle in front of you is at least a ½ block ahead, and then <u>maintain that spacing during the parade</u>.
- 5. Parade ends at the Veterans Memorial Center. Please make arrangements for riders to be picked up at this location.
