REGIONAL POLITICAL UPDATE

Even as the temperatures stay cold, the legislative season in Albany and Washington is heating up. As I write, the Senate and House look poised to pass a nearly \$2 billion COVID stimulus package designed to increase testing, access to vaccines, give nearly every American a stimulus check, and drive sorely needed resources to schools, hospitals, and local governments.

New York's schools and institutions of higher learning are counting on this stimulus. Unfortunately, Governor Cuomo's early budget draft takes money from school districts and fills in the hole with federal stimulus dollars. While, in the short term, this results in no loss of funds for most districts, the stimulus funds will not be there next year. The state is creating another version of the GAP elimination adjustment, a multi-year spending cut to school districts. NYSUT is doing all it can to make our legislators know that this is unacceptable. In order to address the needs of our students, we'll need more resources to both tackle any learning losses but also address the social and emotional needs that come with over a year of a global pandemic.

NYSUT is focused on raising revenues from the wealthiest New Yorkers so that we can fund essential services. While many New Yorkers have been struggling with the virus, the state's billionaires have gotten much richer. Since the beginning of the pandemic, NY's 141 have grown their collective wealth by \$81 billion to over \$600 billion. NYSUT is supportive of common sense bills like a small increase in state income taxes for those earning over \$5 million per year. There are zero such ultra-millionaires in Central New York.

As we continue to adapt our strategies to stay safe, Committee of 100, our annual lobby day, will look a lot different this year. Instead of one day in which thousands of NYSUT members take to the state Capitol to meet with their elected officials, we will be holding hundreds of meetings with legislators, virtually over video-conference, during the first full week of March.

Our in-service members are grateful for your continued activism. By staying involved, you make this difficult year more bearable. Many of our in-service members are having the most difficult year of their careers. Having to re-learn lesson planning for remote, hybrid, and in-person socially distanced lessons has been an extreme challenge. Add to that the fears of contracting the virus and bringing it home to loved ones and you can imagine the stress of this year. In some districts, our hard working support staff, aides, bus drivers, school lunch workers and others have been furloughed or laid off.

What??? Union for Life???? What do I need the Union for now that I am retired?

How am I connected to my local union, regional organization (the Retiree Council or RC), NYSUT and AFT/NEA? Why do I still hear from these organizations? When you were an in-service member, the connections to your local, NYSUT, and AFT/NEA were more obvious. Our union was there to help us negotiate our working conditions, guide our working conditions, act for us, and call us to action on various issues and events. As we moved into retirement, that connection may seem less obvious.

First, most of us notice that our pension does not have union dues taken from it. For that reason, some feel you no longer belong: NOT TRUE! We do not pay dues to NYSUT or AFT, but we are still members. If your local requires retiree dues, payment of those dues is a requirement for local, NYSUT and AFT retiree membership. That gives us access to all the benefits and services of our union. Many continue to use items such as car, home, and life insurances offered by member benefits. Others may pick up new items such as Lifeline for themselves or loved ones, elder-care law packages, hearing aid packages as life events change. Some continue to be involved helping to guide the Regional Councils and chapters. It is important that we all help and are aware of our Union involvement. In retirement, what happens with our local could impact us and our benefits. What happens at the state level absolutely could impact us. And at the national level, the impact on our lives is very evident.

Please make sure you keep the relationship with your local to ensure you stay informed. Our Retiree Council needs you to be involved to ensure that our issues remain in the forefront. Also, as we are retired, we can offer our time and wisdom to assist those still in service. Please look for materials from our RC and NYSUT, read them, and make sure that your current email is available to get updates. Get involved in the work AND FUN that our retirees will again be experiencing soon!




