### IX. New Business

- Best and Brightest Award: Presented by Nancy Walker and Scott Craver
  - PPA received Best and Brightest Bonus funds for both schools for the 2018-2019 school year.
  - Prep received the funds based on one category and Primary received it based on 2 categories.
  - Due to the number of returning teachers, the number of students, and the amount that was received, the Primary teachers receive almost the same amount per person as Prep even though they achieved an additional category.
  - The expected amount of bonus advertised was \$2,500 which was a considerable decrease for many teachers that had received the bonus in the past due to the new calculations.
  - The state and county are aware of the concerns and have indicated this is a state-wide issue, but no additional funds will be provided.
  - Consider using approximately \$20,000 of operating funds to supplement the Best and Brightest bonus funds so that the Primary staff receives the full bonus amount they earned.
