## Minutes of October 16, 2023

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Walter Rollin, Sheila Lanning, Matt Combs, Nora Klebow, T.J. Denes, Amber Fry, Carl Strekely, Tyler Honoshofsky, Amy Papuga, Robert Papuga and Lorain County Prosecutor Assistant Prosecuting Attorney Greg Peltz. *Motion* by Holmes with a second by Rollin to approve the minutes of October 2, 2023 as written. Roll call: three yeas. Checks 10455-10464 and payments totaling \$22,736.31 were approved for payment. *Motion* by Rollin with a second by Holmes to authorize *Resolution 2023-48* accepting the amounts and rates as provided by the Lorain County Auditor. Roll call: three yeas.

### **COMMITTEE REPORTS:**

**WATER-** Lamb: Evaluation for General Manager filled out, currently conducting a mandatory lead line inventory.

**LORCO-** Lamb: Board training with the story of the origination of the organization.

**AMBULANCE-** Holmes: Attended training 10/03/2023, September miles 4,174 year to date 36,471. Maintenance costs September \$3,472.14, year to date \$26,843.29. Huntington runs September 11, year to date 77. District runs September 128, year to date 1069.

**FIRE-** Rollin- New radio and base station ordered, Chili cook-off 11/4/2023 at the Eagles.

**SHERIFF-** 43 incidents in September.

**OPWC & SWAC-** Combs: sent email to Romancak on new MOU for second Stewart Road culvert pipe using remainder of \$45,000 grant.

**CEMETERY-** Rollin: Missed the 2024 Grant application. Called with no answer Leslie Lowe regarding her request on replacing headstones. Called and no answer on ancestry question from Elizabeth Long Palmer. Lanning: call from Richard McConnell about a letter sent requesting the burial permit for his recently interred wife Gail. Laubenthal performed initial services in 2022 for wife, Eastman handled interring cremated remains in 2023. Mr. McConnell did not have a permit and called Eastman. The permit was mailed to Township by Eastman. Also asked several questions about headstone and foundation sizes.

**RECYCLING-** Lanning: third quarter recycling 14.25-ton, solid waste 73.44 ton. Lamb: thank you to everyone for working dumpster days. Combs: tires were dumped in the middle of the night and taken care of.

**ROADS-** Combs: took down 1 of the stop ahead signs on Stewart Road. Will take down the other after Oops called. Could use three more loads of patch if the weather holds out.

**EQUIPMENT-** Combs: still working on tax removal from the Cummins invoice, will email tomorrow. **ZONING-** Klebow: updated the Zoning report and briefly reviewed some of the items.

### **PREVIOUS BUSINESS:**

Holmes: In process of getting clearer plans for safety building. Lanning: the surety bond was returned twice for incorrect address. Emailed Geauga Highway after discussing with Lorain County Prosecutor's office and Geauga provided a third address for bonding company. Sent to new address today.

### **NEW BUSINESS:**

Lanning: call from Lorain County Office on Aging about remittance of money from Aluminum recycling for meals on wheels. Neighborhood alliance given the responsibility of meals on wheels in September. Donation will go the Southern satellite office on aging. Filed the yearly SAM federal report. The
