
Update on Advocacy

Although we are all severely restricted in our movements, NCJW has provided an abundance of educational webinars and tools for remote advocacy. On May 20, there was a successful digital lobby day with representation from all over the country. We wrote emails and called our senators, representatives and governor to let them know that we need the funding for safe elections with unfettered access including expanded vote-by-mail, voter education and early voting. A group of about 14 women from Florida had a digital lobby visit with Tom Boodry, Senator Rubio's legislative aide. While not the same as an in person visit, it was worthwhile and something we could easily do with our state representatives to maintain contact.

Legislative update: Judge Hinkle has ruled AGAIN that SB7066, passed by the FL Senate, which would gut Amendment 4, is unconstitutional and essentially an illegal poll tax. He ruled that it is the responsibility of the state, not the citizen, to determine any monies owed. The state has not set up a system to do this. Amendment 4 enables citizens who have completed their sentence and parole (excluding murder and felony sex crimes) to regain their right to vote. It passed in 2018 with over 65% of the vote. The governor has lost this case numerous times but has 30 days to appeal AGAIN, creating more confusion and barriers to registration. Right now all felons who have completed these requirements can register to vote. The case goes to the 11th Circuit Court of Appeals and then, potentially, to the Supreme Court.

The forced parental consent bill (SB404) mandating that Florida minors have a notarized parental consent before getting an abortion goes into effect on July 1. There is still the arduous process of judicial bypass to circumvent this requirement but it is difficult, and especially hard with such a time sensitive issue.

Please continue to contact your Governor, US senators and representatives to let them know how important financial stimulus packages are to working people and TRUE small businesses and to let them know which issues are important to you. It is helpful to identify yourself as a person of faith in your communication. As always, NCJW has many letters you can just sign and forward, but it helps to include even a short personal comment.
