LCFF Bluegill Outing Report



The weather held in the morning, became drizzly for lunch, and finally started to pour down as we were packing up. Jerry cooked them up, they were great as usual. Plenty to eat, fish, macaroni salad, Pea salad, Baked beans, beverages and Oatmeal cookies.

Cutthroat.....and Water.....of the Month

Unfortunate this wasn't the final question for Jeopardy as James Holzhauer's reign would surely be lost to Brian Davern on this one. James wouldn't stand a chance and Brian would 'a sent him home crying to his mama. Brian whipped back "what is Paiute Cutthroat and Silver King Creek" as the answer to May's Cutthroat sub-species and local water.

Now anyone recognizing the Paiute as the species shouldn't have had a hard time identifying Silver King Creek as the water given that is the only recognized habitat the Paiute is native to. It is recognized as inhabiting the uppermost headwaters of the East Fork Carson River after successful efforts to introduce them to streams neighboring Silver King. Location is entirely in California just across the Nevada State Line and just on the west side of the Sierra Nevada divide. None are known to exist anywhere else.

Paiute cutthroat trout were one of the first animals in the nation to be listed as Endangered in 1967 under the Federal Endangered Species Act. In 1975, they were downgraded to Threatened to facilitate recovery actions. California Fish and Game jealously protect the Paiute with a zero tolerance for fishing in the streams where they are currently found. There are plans to expand its range to where it has been presumed to exist historically, at which time there may become a very limited fishery opportunity, hopefully within my lifetime.
