"Were entirely ready to have God remove all these defects of character."

He said: The true manner of God's working is illustrated by a simple anecdote.

A certain man was working in his garden, assisted by his little girl who had undertaken the task of watering the lawn by means of the usual rubber hose. Suddenly she cried out: "Daddy, the water has stopped." The father looked over, and, taking in the situation quietly, said, "Well, take your foot off the hose." "Emmet Fox"

So, if I "take my foot off the hose" then all of God's power will rush forth and my defects of character will be taken away, right? I believe I grasp this and have a prime example of this healing power demonstrated by my sobriety. If you hear this then you may be asking and wondering, "What is then stopping me from the willingness to take my foot off the hose?"

Before I can answer that I should explain that there are 3 separate parts of myself involved:

Physical: this part of myself is my basic needs to survive and includes breathing, drinking, eating, sleeping, procreating and companionship relations. Protective instincts also assist with continuing life. These are things I cannot live without.

Emotional: This aspect of my life makes me human and each one of us is different based on our life experiences. I learned to assign certain emotional attachments to eating and drinking. I created emotional bonds with people, places and things, along the way being taught by various educators a "value system" to apply. Emotions are necessary and communicate our experiences in a very individual way. Emotions can get the best of us and create problems and challenges.

Spiritual: This is the part of my being that I had overlooked for too long. Within me is an individualization of God, separate but not detached.

She said: After I openly admit my faults and verbally take responsibility for my actions, am I "willing" to have God remove my character defects?

I think that willingness is the key in Step 6. What is the definition of willingness? Willing, according to the Webster Dictionary, means "ready and eager to act."

Am I willing to let go and let God change my thinking and beliefs? Change! Me? Really? Well, just maybe a little tweak here or there but generally speaking, I thought I was just okay.

I was NOT prepared to have all of my defects of character removed. I found that some of them assisted me in my daily living because they became a part of my personality. I also found that a few of the character defects I listed were not defects but assets such as gullible — easily duped or cheated. As I continue my journey in sobriety, I find a character asset to be a defect, such as detachment — holding others responsible for my feelings. This is why it is important for me to have a sponsor.

My sponsor points out the difference between my assets and defects. Identifying the character traits is important and necessary because of my delusional thinking. As I trudge the road to happy destiny, I am constantly reminded that I am human, with human qualities. I am not a bad person trying to be good. I am a recovering alcoholic trying to get well. My worst day sober is far better than my best day intoxicated. I am able to identify, be completely prepared, and take responsibility for my words, actions, and thoughts. I am alert, aware, and yes, willing.

I choose to abandon limited objectives and move towards God's will for me. I now desire to do God's will. I seek to be of service. I am ready for change! I need change! I want change! If I am narrow minded

He Said: (cont.) Within me is the intellect of God with the ultimate logical answer to what is best for me. **Going all the way back** in Step 3 I asked God to take away my difficulties. However as long as I hold on to any defect, unwilling to let go "I am "stepping on the hose." Step 6 was not an all or nothing step for me it was on a 'need to let go' basis. All of my character defects involved short term (short sighted) gratification. I am starting with the most offensive and as I grow spiritually my perception will expand.

I trust that as I proceed I will continue to have the positive results, understanding that the hardest part is the willingness to surrender to a positive change.

Bill Wilson

Bill Wilson was the co-founder, along with Dr. Bob Smith, of Alcoholics Anonymous in 1935. Bill Wilson believed "one alcoholic talking to

another" was key to recovery and based the AA program on the Twelve Steps, a spiritual connection to a higher power and the "Meeting" concept



Dr. Bob Smith

Dr. Bob Smith was the co-founder, along with Bill Wilson, of Alcoholics Anonymous in 1935. "Smitty" or "Dr. Bob", as he was known to AA friends,

was instrumental in assisting Bill Wilson turn a small group of recovering alcoholics, known as Alcoholics Anonymous, in Akron, Ohio in the late 1930s, into a worldwide organization.



The Month of May in Our History:

May 1939: In A.A.'s beginning the first "Intergroup" was called the "Central Committee" in Cleveland, Ohio. This was 4 years after our cofounders first met; a committee of 7, including Dr. Bob was meeting once a month to 'coordinate' efforts regarding sponsorship and hospitalizations.

Dr. Bob was not only a supporter, but an active participant of this committee.

May 1943: The second Intergroup office opens in Columbus, Ohio. In May 1944 Los Angeles opens their office. A.A. was not easy to find but selected groups of priests, ministers and judges in the early days had the Intergroup's phone numbers. These numbers were not listed anywhere else!

Before the first General Service Conference was held in New York, April 1951, 16 Intergroups were serving local groups. Today there are over 1800 of these offices in North America!

May 1902: Dr. William Silkworth married Marie Antoinette Bennett while he was working and developing his theory about alcoholism at Bellvue Hospital, New York City.

May 20th, 1908: The Birth date of Sybil Maxwell; Born: Sybil Doris Adams in Simmons, Texas. She will become the first woman west of the Mississippi to sober up in A.A. and stay sober.

May 1932: Rowland H. visits with Dr. Carl Jung in Zurich, Switzerland for one year to 'cure' his alcoholism. Dr. Jung finally told Rowland there was no medical or psychological hope for an alcoholic of his type, except perhaps a spiritual conversion.

Rowland returned to the U.S. and joins 'The Oxford Group.' This is considered by most historians as the first link in a chain of events that led to the founding of Alcoholics Anonymous.

May 12th, 1935: Bill W. goes to Akron, Ohio on a business trip that fails, where he will meet Dr. Bob for the first time. Because of this meeting most archivists believe that the birth of A.A. took place one month later.
