## Items for consideration for action and discussion at the August 13, 2020 Meeting

 Forsyth County Interlocal Agreement / Covid-19 Funds Discussion Scott: Forsyth County received \$13,889,626 from two allocations of Coronavirus Relief Funds from the General Assembly, and is required to share such funds with municipalities.

Doc: Our portion is \$60,060.

Scott: The town's deputy is considered front line so we could use the \$60,060 towards his pay.

3. Sweepstakes Operations Discussion

Scott: The Town of Kernersville has recently sent notice to all sweepstakes operations within their town limits that their operations are illegal under NCGA statutes and will not be allowed to reopen if and when the current COVID-19 restrictions are lifted by the state.

Doc: Now, the Kernersville Police Department has written a letter to all owners and operators of sweepstakes and fish games businesses in Kernersville. You have a copy of the letter in the agenda. Starting June 26<sup>th</sup> the Kernersville Police Dept. will begin enforcing the ban on electronic sweepstakes machines, video gaming machines, and slot machines including fish games and like devices.

Vernon: Very good letter. We should do the same.

Wesley: They are open now in the county.

Doc: If they are closed in the city now they won't be allowed to reopen. They will want to come here.
