LETTER FROM THE PRESIDENT

Dear Crestwood Members:

Summer will soon be here and the pool board has been working hard through the off-season, preparing for another funfilled season.



We welcome new board members Gwen Stoltzfus, Ellen Nonnemacher and Lauren Hoover. Thank you to Jodi Daniels, Pat Monahan, B-bop Heebner and Sean Hyman for their years of service to the pool and to the board, as they have all decided to step down from their positions. We appreciate their contributions and look forward to seeing them this summer, as they enjoy some relaxing time at the pool!

Aside from reorganizations within the board, we welcome a new Pool Manager, Ashley Tamburro and a new Snack Bar Manager, Terry Behney. PAC has also reorganized with a new board. Hopefully all of these changes will allow us to continually improve Crestwood Pool.

We had some lengthy discussions regarding our budget, our revenues and our expenses. Our expenses for chemicals, utilities, salaries, maintenance, insurance and supplies are constantly rising. Due to the diligence of our buildings and grounds committee and their preventative maintenance, the structure and mechanics of our pool are in very good shape. However, we want to also take financial preventative measures to be sure we can always keep your pool in top condition. So after many discussions, we have decided to slightly increase our dues. It has been 5 years since we have raised dues and only the 2nd time in 11 years. The family membership has been increased by \$20; the single membership by \$10 and childcare by \$5. Senior rates will not increase. Late fees, which are assessed against dues paid after May 1st are being increased \$15. We hope these increases do not put a strain on any of our members.

Despite the many changes, Crestwood pool will remain the same fun-filled, family oriented pool. Think SUMMER!!!!!

Attention Returning Members,

For the past several seasons our membership has been at full capacity by opening day or soon after. Please remember to send in your invoice on time, postmarked on or before May 1, 2017 to guarantee your spot and avoid the \$35.00 late fee. That late fee is a \$15.00 increase from last year and we are hoping to motivate our members to get their invoices in on time which helps us out tremendously on opening day. Invoices MUST accompany payment! If you are mailing after May 1st please include that late fee or you won't be able to pick up your membership cards until that is paid. Clean-up fee is included in the price of membership just like last year. If you attend a clean-up day, you will be reimbursed the amount of \$50.00. Membership cards will only be issued once all dues and fees have been paid in full.

Also, don't forget to purchase your guest passes in advance to get the discounted price of \$7.00 (\$10.00 at the door without having a guest pass). There is no limit to the amount of guest passes you can purchase. Guest passes are good for a one time pass but you have two seasons to use them before they expire.

Just a friendly reminder: If you have any address changes or phone number changes, please contact me or the pool manager. We need to make the necessary changes to our records, so that you can continue to receive information about the pool. You can do this by emailing me or telling someone in the office during the pool season.

There is still stock available for purchase for new members. The option for a one-time, non-stock initiation fee is also available. If you have stock that you would like to sell, please contact me or the manager to get on our list of sellers. Remember every year that you don't join the pool \$50.00 gets deducted from the value of your stock. Therefore, it is important to join every year or sell your stock as soon as you no longer want to join the pool.
