




Text-Message Reminders for Probation Appointments

Do text-message appointment reminders reduce failure to report on probation?

Agency: Clackamas County Community Corrections (Oregon) Trial Completion Date: 01/15/16 Pracademic*: Kelli Zook

Context One-third of probationers fail to complete the terms of their supervision (BJS, 2014).

Failure to report deprives probationers of program benefits, wastes public time and money, and increases the risk of incarceration.

Key Finding

Clackamas County Community Corrections sent text-message reminders to probationers and reduced their failure-to-report rate by one-third.



Results

Clackamas County Community Corrections The failure-to-report rate for probationers who received a text-message reminder was 20.0%, compared with 29.5% for the appointments. 





