Many States have been requesting the Gerontology Certification from NALPN, to come to their state. Beverly Morgan, and Missy Moore will honor all these requests for the NALPN Education Foundation.

The NALPN 70th Annual Conference date and place has been changed due to high room rates in New Orleans. NALPN will hold its conference at the Scarlett Pearl Hotel in Biloxi, Mississippi from Oct. 3rd-5th, 2019. Room rates will be about \$69/night, several restaurants and casino are in the hotel. Governor Ever's will be presenting a budget proposal this spring. The Joint Finance will then go around the state for public hearings. This is the time to read the details, find facts, ask questions, testify at a joint finance budget hearing on subject of interest to you.

It is very important that we are listening, reading, and teaching the legislators in our district. Yes, we need to be vocal on issues that you know! Below is a short summary of some issues that will be undoubtedly be brought forth

again in some fashion. Then it is time for YOU to take some action.

In a venue to fact friend about nursing from an objective manner, a bill was passed, law signed into effect by then Governor Doyle that created the nursing surveys so that RN's and LPN's needed to 'fill out' before they could get their license. The first survey to renew ones license was mandated in 2011. The detailed analysis learned from this document gives greater insight on the needs to provide quality safe care while protecting the public. There were rumbles in the last legislative session to disband the survey. If that were to happen, it would be a great step back for standards of care. It would further negate the data needed to plan for the future. Share your knowledge!

Occupational Licensure is another issue that is 'out there'. As licensed persons, we are well aware our license is to protect the public, we know that 'we' must meet a standard to practice. It is not just nursing; but electricians, beauticians, plumbers, accountants, physicians, the list goes on. There are some who attempt to message talking points that licensure is a nuisance or 'just fill the post' with a body.

A bill was introduced to decrease the hours of educating persons to be a certified nursing assistant from the 120 hours which has been law since 2008. Do we less qualified persons caring for our frail and elderly?

Human life is to be held with dignity, there will be days when we need to share that with our legislative representatives.
