Approval of Minutes:

Mayor Hart swore in Christopher M. Wermuth as Amelia Village Police Officer. Chief Friend pinned his badge on.

Legislation:

O-2013-42 AN ORDINANCE CONFIRMING THE MAYOR'S PROBATIONARY APPOINTMENT OF CHRISTOPHER M. WERMUTH AS A PART-TIME POLICE OFFICER IN THE AMELIA VILLAGE POLICE DEPARTMENT, AND DECLARING AN EMERGENCY.

It was moved by Mr. Campbell, seconded by Mr. Dickerson, to suspend the rules requiring three readings. Passed 5–0.

It was moved by Mr. Campbell, seconded by Mr. Dickerson, to adopt the Resolution. Passed 5-0.

Police Chief Report: Chief Friend reported there is a scam going about involving counterfeit US Postal Service Money Orders. He urged everyone to be careful about responding to offers of money if any money is to be paid by the recipient.

Chief Friend also reported the new handguns had arrived and two officers are certified Sig Sauer Armorers. The Chief also announced September 21 is "Thank a Police Officer Day".

Public Input: None

Council Input:

Councilmember Campbell: Mentioned Auditor of State Southeast Regional Liaison Christa Criddle came by and gave information to Mayor Hart about Amelia becoming a city. Ms Criddle said the Auditor of State is pleased Amelia is being proactive. She wants to meet with Council in October.

Mr. Campbell also said the street repair project has started.

Councilmember Gerber: Ms Gerber asked about Council pay raises in light of the recent changes in eligibility for OPERS pensions. Solicitor Carney said the minimum salaries are \$600 per month for pension eligibility and \$1,000 per month for insurance eligibility.

Councilmember Dickerson: Mr. Dickerson reminded everyone about the 2013 Halloween Festival scheduled for October 19 at Spencer Shank Park from Noon until 4:00 PM. He mentioned there was a strong showing from various businesses to support the Festival. The Village will again be holding a house decorating contest in conjunction with the Festival.

Mr. Dickerson asked Council about installing two lights on timers at the pond in Sedona Ridge for approximately \$1,500. After discussion, Mr. Dickerson moved, seconded by Ms. Gerber, to authorize the purchase and installation of two lights on timers.

Mayor's Comments: Mayor Hart announced there would be a Public Hearing on Rental Registration on September 24 at 6:30 PM.

Mayor Hart also announced something will soon be coming to every household in Amelia.

Mayor Hart appointed Ms Katie Krafka to replace former Councilmember Chuck Thacker on the Finance Committee. The appointment would be until December 31, 2013.
