

2022 DAYTON ALL*STAR QUALIFIERS RULES

FORMAT:

- The Dayton All*Star team will consist of a total of 28 men and 15 women who will be determined by qualifying scores.
- The top 24 men & 12 women are guaranteed a spot on one of the 6 Men's, or 3 Women's teams. The remaining players are alternates and will be utilized as needed. Both Men's and Women's coaches will be appointed by the DDA.
- The Dayton All*Star teams will compete against All*Stars teams from Cincinnati, Columbus & Cleveland in the Quad-City Challenge on Sunday, December 11, 2022.

ELIGIBILITY:

- Any Dayton (and surrounding area) resident may qualify. Quad-City Rules state, <u>"All team members must reside within an 80-mile radius of their club/association's mailing address."</u>
- > You **do not have to be a paid** DDA member in order to qualify or be on the All*Star team.
- > Non-DDA members are entitled to All*Star team benefits, but not full DDA membership benefits.
- > Players who are NOT in good standing with the DDA are excluded from qualifying.
- DDA winner of men's and women's City Champs are automatically on the All*Star team. Number 24th position for the men and 12th for the women.

BENEFITS:

- ✓ All players that make the Dayton All*Star team will receive a personalized shirt. Coaches will also receive a personalized shirt.
- ✓ The All*Star shirt must be worn during the Quad City Challenge.
- ✓ Only the top 6 men and the top 3 women will receive a \$50 bonus.
- ✓ Failure to participate (in good faith) in the Quad City Challenge will result in a forfeit of the bonus and shirt.
- ✓ As a paid DDA member, you have free entry to the annual banquet, participation in Divisional Single Events, and participation in the City Championship event. Membership dues are (\$20.00) yearly.

QUALIFYING:

- 1) Qualifying fees are \$3.00 per sheet. Fees *must be paid* before the darter begins any qualifying attempt(s).
- 2) All sheets paid for are non-refundable and non-transferable. No credit will be extended.
- 3) **Regular qualifying:** <u>A maximum of 3 sheets per person can be purchased at a time and thrown</u>. 3 Additional sheets can be purchased upon the previous 3 sheets being turned in by the scorer, either by qualifying attempt or incomplete sheet (D.N.F.).
- 4) BOGO: <u>A maximum of 2 sheets (buy 2, get 2 free) per person can be purchased at a time</u>. Additional sheets = (buy 2, get 2 free) can be purchased upon the previous 4 sheets being turned in by the scorer, either by qualifying attempt or incomplete sheet (D.N.F.).
- 5) On a REGULAR or BOGO Night any outstanding (UN-scored, returned) or new purchased sheets go to the bottom of the stack so others can qualify. This will also apply to breaks that are longer than the 5-min wait time.
- 6) <u>Men</u> Each attempt consists of 3 games of <u>501 straight in, double out</u>
- 7) <u>Women</u> Each attempt consists of 3 games of <u>301 straight in, double out</u>

- 8) You will be shooting for the lowest number of darts to complete a total of 3 games
- 9) The qualifying score used for determining the All*Star team is the *SUM* of 3 games total for a given qualifying attempt. A game from a different score sheet may not be used to calculate the qualifying score.
- 10) Once a darter's name has been called to a board, you will have a 5-minute (max) wait time to be at the board.
- 11) If a darter is not present at the board by the 5-minute (max) wait time, the qualifier sheet will be placed at the bottom of the stack.
- 12) The darter may warm up 9 darts max (on the game board) before starting each game of a qualifying attempt. The darter must inform the scorekeeper when they are ready to begin each game prior to throwing the first dart of that game.
- 13) Once the first game has begun, all three games *must be completed* without a break.
- 14) For safety reasons: All games will be monitored/scored by DDA board members and/or All*Star Committee Members at tables. Scores must be verified by the scorekeeper before darts are pulled from the board. If there is no verification, the scorekeeper will list that round as a zero (0) score and 3 thrown darts.
- 15) <u>Any darter that is caught intentionally cheating while qualifying or who shows/has an Un-sportsmanship</u> manner will be disqualified from making the All*Star Team
- 16) Each leg of a qualifier consists of 30 (max out) thrown darts or <u>less</u> for a given leg. Once a leg starts, all darts thrown count in succession as the 30 (max out) thrown darts or <u>less</u> for a given leg.

- 17) The sum of all thrown darts counts as the score for a given leg.
- 18) All bounce-outs or robin-hoods are counted as darts thrown and *cannot be re-thrown*.
- 19) A "bust" on dart one or two will be scored as three darts. Dart(s) are pulled and next round begins.
- *20)* If someone gives up during a qualifying attempt, that leg and therefore the entire attempt is unfinished and *may not be resumed* later. The score sheet will be marked D.N.F. for the leg and the overall qualifying score will be recorded as a D.N.F. (Did Not Finish).
- 21) Ties ... <u>Upon the final night of Qualifiers</u> To determine the All*Star Team...<u>On all tied qualifier sheets</u> the lowest score in a leg of thrown darts out of your 3-game total will be used.

Darter #2 has the lowest number of thrown darts out of the tied score of 54

Scheduled Qualifiers:

- There are no open qualifiers. *All qualifying attempts *must be taken* on one of the scheduled dates, times and locations noted on the qualifier schedule. *<u>Subject to change upon the circumstance, advance</u> notice, and with 3 approvals 1 from the DDA President, 1 from the All*Star Chair, and 1 from another <u>All*Star Board Member.</u>
- There will be example shirts to try on at the qualifiers. You must try on the shirt, and sign your name, and your size on the shirt try-on sheet.
- <u>A score sheet must have your correct email and phone number, to contact you.</u>
- The last call to buy sheets will begin 1 hour prior to the close of the scheduled time posted.
- Example: If the closing time posted is 10 pm then we will stop the selling of sheets at 9 pm
- You must purchase all score sheets (3 at a time sold; exception BOGO night is 2) if you wish to attempt to qualify before the respective deadlines. <u>No sheets are sold after the 1 hour prior to the close of the scheduled posted time.</u> *There will be no exceptions!*
- Anyone who purchased score sheets prior to the closing time may stay until they have thrown as many qualifying attempts as were paid for.
- A valid score sheet will have the darter's name, phone number, shirt size, e-mail address, and the \$3 purchase price marked paid on it by the DDA Board/All*Star Committee members running the qualifying for the night.

ADDITIONAL INFORMATION:

- 1. Board/Committee member times are reserved for board/committee members, which is 1 hour before the start time of the regular qualifiers. <u>No qualifiers will be taken except for the board/committee members</u> <u>qualifying scores</u>. <u>Subject to change upon the circumstance, advance notice and with the approval of the DDA President, All Star Chair and 1 other Board Member.</u>
- 2. All*Star standings will be updated by the All*Star Secretary on a regular basis and distributed to the DDA Secretary, Web Master for posting on the DDA website (to view go to www.daytondarting.com) and posted at DDA sponsor locations.
- 3. The All*Star Chairperson will appoint men's and/or women's coaches, will assemble teams, appoint team captains, and schedule practices. The All*Star Chairperson will possess the list of players names, contact information and shirt sizes.
- 4. The time and place to pick up your All-Star shirt along with those who will receive a bonus will be given at a later date. REMINDER: Failure to participate (in good faith) in the Quad City Challenge will result in a forfeit of the bonus and shirt.

5. All members of the 2022 Dayton All*Star team must be in the Quad City Challenge dart hall <u>no later than 9:30 am on Sunday, December 11, 2022.</u>
