Dear Food Court Vendors:

The Tuscola County Pumpkin Festival Committee has once decided to relocate some of the Festival activities to the Tuscola County Fairgrounds for 2017.

On Friday and Saturday, the Arts and Crafts Vendors will be located inside two of the Commercial Buildings across from the Lion Den and 4H Diner Food Booths. The Hometown Idol singing talent show, children's activities and Dog Shows, will also be relocated to the Fairgrounds. In addition to these activities, the Old Engine and Tractor Club will be holding a Swap Meet on Friday and Saturday at the Fairgrounds.

The Car Show will remain on Main Street Saturday. The Festival Committee is still seeking additional activities for Main Street for Friday.

These changes will affect our Food Court setup and size. We are looking for 6 to 7 vendors for the Main Street location, and 2 to 3 vendors for the Fairgrounds location.

The Lions Den will be serving Breakfast and Lunch on Friday and Saturday, and the 4H Diner will be serving lunch both days.

Vendors on Main Street can setup Wednesday evening after 5:30 p.m. and must be open on Thursday. Vendors wishing to be at the Fairgrounds, can arrive Thursday after 5:30 p.m. and will be open on Friday and Saturday, but will have the option of moving to Main Street Saturday night, for sales on Sunday before and after the Grand Parade.

Due to these changes, we have reduced the registration fee to \$50.00 per day for either location.
