CORRESPONDENCE FROM THE FISCAL OFFICER:

Minutes from the May Meeting being read prior by the Board were approved as read, so moved by Trustee Ellinger and seconded by Trustee Shaw. All were in favor with 2 ayes and no negative votes, motion passed. Working on FY22 budget to submit the auditor's office.

FIRE DEPARTMENT:

Chief Golden reported monthly runs so far have been 13 fire and 32 EMS for a total of 378 runs YTD. Mutual aid was provided to Amanda, Berne, Clearcreek, Greenfield, Hocking County, and Lancaster. A total of 6 run to SCI.

OLD BUSINESS

1. The county engineer's office will keep Hocking Township informed as to the progress of the OPWC on Meister Road. Should be hearing something soon.
2. The trustees will be scheduling a work session with the road employees for Stepath Mound Lane.
3. The Army Corp of Engineers did view the site back in March with the property owner. They stated they didn't see any issues. The trustees asked Fairfield County again to do a water study for the size of the culvert needed to cut down the erosion from Muddy Prairie Run Creek on Pleasant Valley Road.
4. Deputy Hummel and the Health Department will be checking on the property complaints on Hamburg Road. They will advise of the next steps.
5. The property at 188 and Delmont Road is proposed for a Loves fuel station. The city of Lancaster is planning on annexing the property. The Hocking Township Board of Trustees met with the Lancaster Mayor to change the annexation, but they decided not to proceed due to how far in the process they were.
6. A resolution was passed to turn over the Scott Brown property issue to the Fairfield County Prosecutor's office. That packet was submitted.



NEW BUSINESS:


1. The culvert and driveway on Country Club Road will be taken care of by the property owner. The owner will have it contracted out and will be applying for a ROW permit.


There being no further business to discuss Trustee Ellinger motioned to adjourn and Trustee Wolfe seconded the motion.
