## Dale Law Firm: Limited Conservatorships

---

A Limited Conservatorship is a court proceeding whereby an individual or agency is appointed to be responsible for a developmentally disabled adult. These conservatorships are "limited" because an adult with a developmental disability retains the power to care for her or himself and/or manage her or his financial resources to the extent that the court finds that she or he is able to do so. The limited conservator cares for and controls those aspects of daily life that the court finds the adult who is developmentally disabled cannot competently handle. A limited conservator's duty is to help the limited conservatee *develop maximum self-reliance and independence*. Because developmentally disabled adults can usually do many things on their own, the judge will only give the limited conservator power to do things the conservatee cannot do without help.
