THIS DATE IN HISTORY

January 1, 1955 In Hanoi, at a five and 1/2 hour parade attended by over 200,000, Ho Chi Minh makes his first public appearance in over eight years. In Saigon, Lieutenant General John W. O'Daniel assumes duties as chief of the U.S. Military Assistance Advisory Group-Indochina; the focus of his efforts will be to assist the South Vietnamese government in organizing and training the South Vietnamese army. In Washington, the U.S. government pledges additional military aid for South Vietnam, citing the aid agreement of December 23, 1950, signed by the United States, France and the Associated States of Indochina.

January 24, 1957 The Soviet Union proposes a permanent division of Vietnam into North and South, with the two nations admitted separately to the United Nations. The United States rejects the proposal, unwilling to recognize Communist North Vietnam.

January 19, 1961 Outgoing President Dwight D. Eisenhower warns incoming President John F. Kennedy that Laos is "the key to the entire area of Southeast Asia" and might require the direct intervention of U.S. combat troops.

January 4, 1965 In his State of the Union message, President Johnson reaffirms the U.S. commitment to support South Vietnam in combating Communist aggression, saying that, "Our own security is tied to the peace of Asia."

Bills Signed into Law

H.R. 4409 was signed into law by the President on December 14, 2016. This law renames the Department of Veterans Affairs temporary lodging facility in Indianapolis, Indiana as the "Dr. Otis Bowen Veteran House." This bill was introduced by Rep. Susan Brooks (R-IN).

H.R. 4352 was signed into law by the President on December 16, 2016. It is known as the "Faster Care for Veterans Act," which authorizes VA to conduct a pilot program to establish a patient self-scheduling appointment system. Introduced by Rep. Seth Moulton, (D-MA).

H.R. 6416 was signed into law by the President on December 16, 2016. It was introduced by Rep. David Roe (R-TN) as the Jeff Miller & Richard Blumenthal Veterans Health Care & Benefits Improvement Act of 2016 and includes Toxic Exposure Research Act. It also amends health care, homelessness matters, educational assistance, vocational rehabilitation, disability compensation/claims appeals, small business/employment matters, burial/memorial affairs and construction reforms.

VA Medication Copayment Changes in 2017

Washington – The Department of Veterans Affairs (VA) is amending its regulation on copayments for Veterans' outpatient medications for non-service connected conditions. VA currently charges non-exempt Veterans either \$8 or \$9 for each 30-day or less supply of outpatient medication, and under current regulations, a calculation based on the medication of the Medical Consumer Price Index (CPI-P) would be used to determine the copayment amount in future years.

"Switching to a tiered system continues to keep outpatient medication costs low for Veterans," said VA Under Secretary for Health Dr. David J. Shulkin. "Reducing their out-of-pocket costs encourages greater adherence to prescribed outpatient medications and reduces the risk of fragmented care that results when multiple pharmacies are used; another way that VA is providing better service to Veterans."

This new regulation eliminates the formula used to calculate future rate increases and establishes three classes of outpatient medications identified as Tier 1, Preferred Generics; Tier 2, Non-Preferred Generics including overthe-counter medications; and Tier 3, Brand Name. Copayment amounts for each tier would be fixed and vary depending upon the class of outpatient medication in the tier.

These copayment amounts will be effective February 27, 2017:

\$5 for a 30-day or less supply - Tier 1 outpatient medication

\$8 for a 30-day or less supply - Tier 2 outpatient medication

\$11 for a 30-day or less supply - Tier 3 outpatient medication

These changes apply to Veterans without a service-connected condition, or Veterans with a disability rated less than 50 percent who are receiving outpatient treatment for a non-service connected condition, and whose annual income exceeds the limit set by law. Medication copayments do not apply to former Prisoners of War, catastrophically disabled Veterans, or those covered by other exceptions as set by law.

Copayments stop each calendar year for Veterans in Priority Groups 2-8 once a \$700 cap is reached.
