
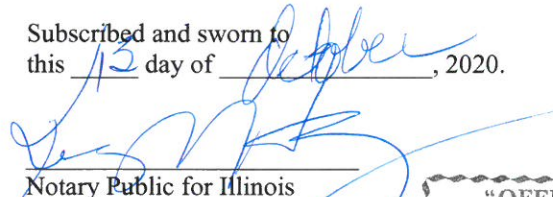

**CALL TO ORDER and ROLL CALL**

The monthly meeting of the Mill Creek Water Reclamation District Board of Trustees (“District”) was called to order at 7:00 p.m. at the Mill Creek Water Reclamation District Treatment Facility, Blackberry Township, Kane County, Illinois on Thursday, September 22, 2020 by Trustee Dougherty. Trustees physically present were Mark Hammond, James Dougherty and Trustee D’Andrea.

**ANNOUNCEMENTS AND PUBLIC COMMENT.** President Dougherty stated that due to the COVID 19 pandemic the Board is still operating under the temporary rules that were ratified at the April meeting and posted on the agenda. Jason Fowler advised that as of 5:00 p.m. there were no emails with public comment and there was no public on the conference call or physically in attendance.

4. **OLD BUSINESS.**

**a. Approval of the minutes of the August 27, 2020.**

**c. Consideration of Draft Budget for Calendar Year 2021.**

Copies of the preliminary budget were provided to the trustees by Jim Hare. Hare reviewed the draft budget by line item and made adjustments according to the trustees' comments. Fowler advised that he would provide dollar amounts for capital projects planned in 2021.

**d. West Irrigation Project, items I and ii..**

(i) *Project update by Shaeffer & Roland.* Fowler advised that on September 30, 2020 a pre-bid meeting will be held and on October 21, 2020 bids will be opened. Fowler asked for a special meeting in October to review and approve winning bid. Fowler stated that work would commence within approximately ten (10) days of awarding the bid.

(ii) *Consideration and approval of Michael Pitstick proposal for winter wheat seeding of West Irrigation land. (\$10,400).* Fowler advised that this is the farmer that tilled the fields and planted last year.

Motion by Trustee Hammond to approve the proposal of Michael Pitstick for winter wheat seeding of West Irrigation land in the sum of \$10,400. seconded by Trustee D'Andrea.

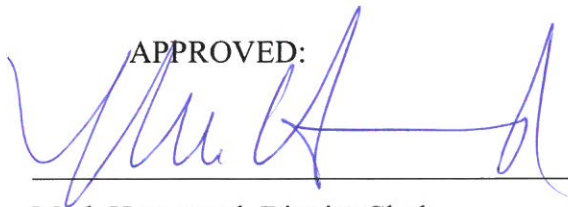
Motion approved.
