NOTICE TO BIDDERS

Sealed Bids will be received by the City of Mount Airy, North Carolina, hereinafter called the City, in the Mount Airy City Engineers office in the Municipal Services Building, 440 East Pine Street, Mount Airy, North Carolina until **2:00 p.m.**, local prevailing time on **March 20, 2019** and then in the Municipal Services Building main conference room be publicly opened and read aloud for the **Factory Street Water System Improvements** includes furnishing and installing all piping, manholes, road crossings, service connections, and appurtenances as described in the specifications and as shown on the contract drawings, including but not limited to **replacement of approximately 3,200 LF of existing 12" and smaller water lines, installation of approximately 800 LF of new 12" water line, replacement of approximately 2,300 LF of existing 8" gravity sewer lines, all related water and sewer appurtenances, and street repairs.**

The City reserves the right to reject any or all proposals.

NOTE: Prospective bidders are hereby notified that they must have proper license in North Carolina under the state laws governing their trade. General contractors are notified that Chapter 87, Article 1, General Statutes of North Carolina will be observed in receiving and awarding this contract.

A separate performance bond and payment bond each in an amount equal to one hundred percent (100%) of the Contract price will be required. A Performance and Indemnity Bond (North Carolina Department of Transportation (NCDOT) –Highway Encroachment Installation) shall be executed by the Contractor. Carriers must be authorized to do business in North Carolina.

All Bidders shall comply with the requirements of North Carolina General Statute 143-128.2. The low Bidder shall provide documentation of compliance.

BIDDERS MUST COMPLY WITH ALL SAFETY REQUIREMENTS AS DETAILED IN THE CONTRACT DOCUMENTS. FAILURE TO PROVIDE DOCUMENTATION OF AN ADEQUATE SAFETY PROGRAM SHALL BE CAUSE FOR THE BID TO BE REJECTED.

Bidders must comply with the provisions of the N. C. Contractor's Licensing Act of 1925, as amended.

The City reserves the right to reject any proposal for failure to comply with all requirements of the Notice or of any of the Contract Documents; however, it may waive any minor defects or informalities at its discretion. The City further reserves the right to reject any and all proposals or to award the Contract which in its judgment is in the best interest of the City. An optional Pre-Bid Conference will be held on March 6, 2019 at 10:00 a.m. in the Conference Room of the Municipal Services Building located at 440 East Pine Street, Mount Airy, NC. Attendance is optional, but all BIDDERS are encouraged to attend.
