



TERMS AND CONDITIONS FOR GREAT KIDS EVENTS EVENTS

Great Kids Events strives to provide a wonderful and memorable event for every child we serve! The following is a list of terms and conditions under which we conduct all of our events. By agreeing to your event contract, you hereby agree to the following terms.

Liability Waiver: Great Kids staff will take every precaution to ensure a safe and fun event for all attendees. When working with children, occasional minor injuries may occur. Event Hosts agree that Great Kids Events and Great Kids Events staff will not be held liable for any damage to event location, or injury to attendees. An event host, preferably a parent, listed at the beginning of your contract, must be in attendance during the entire event. Great Kids Events staff always carries a basic first-aid kit and cell phone in case of emergencies. **In the unlikely case of any damages or injuries, the liability of Great Kids Events and its affiliates is limited to the amount paid by the client.**

Food and Beverage Requirements: Great Kids Events will provide pre-packaged/pre-made food and beverages from well-known third-party vendors. Great Kids Events does not manufacture any food products. If event is off-site, ice cream and/or beverages supplied by Great Kids Events must be placed in freezer/refrigerator (provided by host) upon arrival at event location.

Policy for Events of Children 3 years old or Younger: For events where the majority of children are 3 years old or younger, the host agrees to ensure more parent presence and involvement at the event. GKE reserves the right, based on the attention and interest of the young children and the cooperation of their parents at the event, to shorten an event.

Policy for Changes to Event Reservation: Event host agrees to provide final guest count and guest list 7 days or more in advance of event. Event host may change party theme up to 14 days before event, and/or number of guests or details of party reservation up to 7 days before event, without penalty of extra charge. Great Kids cannot guarantee supplies for guests added within 7 days of event. Event host will be charged for any guests that do not attend event, based on final count provided 7 days in advance, plus any last-minute additions that Great Kids Events is able to accommodate.

Miscellaneous Terms and Conditions

- We do not currently have any centers that we operate. Please ask about the capacity at any facility where you hold a party. We cannot be held responsible if you have more children than allowed in a location.
- Please be mindful of how loud the adults are in proximity to the party. We may ask the Party Hosts to handle loud parents and we have the right to pause a party if there is too much parent noise.

Payment: A \$100.00 non-refundable deposit must be received to confirm the date and time of your event. Events over \$1000 require a 50% deposit. You must agree to the terms and conditions of your contract by signing and returning your printed contract within 7 days, clicking "I agree" on the event organizer page of your *Great Kids Events Funvitation*, or by paying the deposit requested on the contract. Balance of total payment will be due immediately upon conclusion of event. Any tolls or parking fees incurred by Great Kids staff will be charged to the client. We prefer that you pay any gratuities by cash, but can accommodate a credit card if necessary.

Returned Check Fees: returned checks are subject to a \$35 fee, plus any costs of collection.

Cancellation: While your deposit is non-refundable, should you need to cancel your event with more than 1 week notice, Andy's Parties/Great Kids Events will work with you to find an alternate event date within 3 months, and will apply your deposit to that alternate event date. If you cancel your event within 1 week of the contracted event time, your deposit is forfeited and not applicable to any future event.

Inclement Weather Policy: We will make every attempt to hold your party during inclement weather. If it is reasonable to run your party (roads

cleared, etc), you will be expected to have your party on the contracted date. Otherwise, you must reschedule your party for the next date that Great Kids Events has available. If a party is not postponed by 8:00am on the date of your party due to extreme inclement weather, you must pay the entire balance in full.

If we feel the weather is unsafe, we have the right to postpone your party to the next mutually-agreed upon date with no penalty.

Scope of Agreement: This Agreement constitutes the entire agreement between the parties hereto and supersedes all prior written or oral agreements or understandings, in each case with respect to the subject matter hereof.
