DUI & PHYSICAL CONTROL



Driver License

Department of Licensing (DOL)

- •Request Hearing within 20 days of arrest
- •Mail form close to day 20
- •Mail Certified and send \$375 check
- •Hearing must be within 60 days of arrest
- •Hearing is by telephone
- •Hearing Officer is employee of DOL
- •Trooper/Officer can be subpoenaed
- •Subpoena must be served 10 days prior
- •If Officer does not appear, you win

Arraignment

The Court System

Time to enter into a disposition; or Continue for further negotiation; or Continue to argue motions; or Confirm for Trial

Motions

Separate hearing to argue legal issues

Jury Trial

Most DUIs don't go to trial, but for those that do, trial lasts 1-2 days

Ignition Interlock License (IIL)

An IIL is a restricted license that allows you to continue driving if you lose your license because of a DUI. You will need an ignition interlock on all vehicles you drive (except work vehicles) and SR 22 insurance.

Ignition Interlock Device (IID)

Required if convicted of DUI or for the Ignition Interlock License. To be removed the DOL requires 4 months with no problems of failures.

POSSIBLE REQUIREMENTS

Alcohol/Drug Evaluation [Required]

Complete as soon as possible.

You must complete what is recommended.

DUI Victim's Panel [Required]

2 hours long and is presented by victims of DUI **Probation**

5 years for DUI/Physical Control; 2 years for others. Maybe supervised or unsupervised.

DEFERRED PROSECUTION (DP)

The DP you to have your DUI dismissed on the condition that you complete a 2 year alcohol/drug treatment program. The program is divided into 3 phases: i) approx 3 months long (3+/week); ii) approx 6 months long (once/week); iii) approx 15 months long (once/month).

PROS (+)

- •DUI dismissed (in 5 yrs);
- •No loss of license;
- •No jail.

CONS (-)

- •2 years of intensive treatment;
- •Considered a "prior" DUI;
- •Only one DP a lifetime;
- •Costly unless good insurance.

Possible Amendments/Reductions

Reckless Driving

Def'n: Driving a motor vehicle in a willful or wanton disregard for the safety of persons or property Penalties: 30 day license suspension; SR 22 insurance

Negligent Driving 1st Degree

Defn: Operating a motor vehicle in a manner that is both negligent and endangers or is likely to endanger any person or property, and exhibits the effects of having consumed liquor or an illegal drug. Penalties: No mandatory minimum penalties

Minor DUI

Def n: Driving a motor vehicle, while under the age of twenty-one, and having an alcohol concentration of at least 0.02.

Peantlies: 90 day license suspension
