Dear Judge Hanshaw:

This is to certify that this is a true and correct report of the findings in the above case as derived from the following: 1) Historical data from outside sources; 2) Medical history, physical and neurological examinations; 3) Laboratory and other physical studies; 4) Psychological assessment by staff psychologist; and 5) Psychiatric evaluation including direct psychiatric examination by the examining psychiatrist.

Diagnosis: Axis I - Alcohol Abuse; Marijuana Abuse  
Axis II - Antisocial Personality Disorder

The defendant appears to be aware of the nature of the charges and the proceedings taken against him. He is capable of cooperating effectively with an attorney in the preparation of his defense.

At the time of the commission of the alleged offense, the defendant did not lack the capacity to appreciate the criminality of his conduct or to conform his conduct to the requirements of the law.

It is the opinion of the forensic evaluation team that at the time of the commission of the alleged offense, Heath Stocks, had the capacity to have the culpable mental state to commit the offense charged.


He is ready to return to Court for disposition. The sheriff of Lonoke County was notified to send for this patient.


