

Changes proposed by Matt Sutterfield (President) on 2/17/2021

Summary of changes: Updates the way matches are posted and club members notified, allows treasurer to use a debit card for payment, allows online meetings and limits length of meetings before matches.

#### Article IV

**Original:**

In order to keep matches to a manageable size, participation may be limited to a predetermined number of entrants. Signup will be on a first-come, first-served basis at least 2 weeks prior to the match. Signup will be on The Club Website (JoCo3Gun.com), with members receiving an email notification no less than two (2) days prior to sign up sheet being posted. Members without email will be notified by posting in the JCSA clubhouse and must sign up by telephone before the online list is full. A waiting list will be established to fill in for any cancellations, in order of entry.

**Modified:**

In order to keep matches to a manageable size, participation may be limited to a predetermined number of entrants. A waiting list will be established to fill in for any cancellations, in order of entry. Signup will be on a first-come, first-served basis at least ~~2-1~~ weeks prior to the match. Signup will be on [Practiscore](#), with members receiving an email notification [when the match is posted](#). ~~no less than two (2) days prior to sign up sheet being posted. #### Article VI

**Original:**

Treasurer shall be responsible for all monies due The Club and shall be accountable for all funds belonging to The Club. **Original:**

The Club shall meet regularly for 10 minutes following the Safety Briefing at the Monthly match to attend to routine Club Business. The President or Executive Committee shall have the option of Tabling or calling for a Special meeting if items are expected to run past 10 minutes. The Executive Committee shall assign a Match Director and an alternate for the following month, both of whom must be certified NRA Range Safety Officers. Special meetings may be held at any time on the call of the president or on demand, in writing, to the secretary by three (3) members of the Committee.

**Modified:**

The Club shall meet regularly for 10 minutes following the Safety Briefing at the Monthly match to attend to routine Club Business. The President or Executive Committee shall have the option of Tabling or calling for a Special meeting if items are expected to run past 10 minutes. The Executive Committee shall assign a Match Director and an alternate for the following month, both of whom must be certified NRA Range Safety Officers. Special meetings may be held at any time on the call of the president or on demand, in writing, to the secretary by three (3) members of the Committee. [Special meetings may be held in person, or online via video conference, at the discretion of the board, after sending notice of the special meeting to all club members via email at least 3 days in advance.](#)
