As of the end of June the association had \$63,728.61 in the operating account and \$810,254.62 in the reserve accounts. The outstanding delinquent account totaled \$109,905.76. Kenton Heider made a motion to approve the financials as presented, Lou Bruce seconded the motion, all in favor, motion carried.
- b. Delinquent accounts- the board reviewed the delinquent accounts.
- c. Violations- the board reviewed the violations. The board will work with Montage and the City of Pearland to cure violations.

5. COMMUNITY PROJECTS

a. Community Events –movie night in the pool, August 5th. Movie will start at 8:00pm.

b. Ricki Willoughby discussed having "Trunk or Treat" for Halloween on October 28th, 6:00-8:00PM. She said volunteers will be needed.

6. LANDSCAPING UPDATES

a. Sussan Summers with Montage is waiting on landscape quotes.

7. NEW BUSINESS

- a. Flock Cameras- Ricki Willoughby elaborated on the cameras. She informed the owners present on exactly how the cameras work and also that they were linked to the police department. She also mentioned that the purchase of the cameras might possibly raise the assessments. She also mentioned trying to get some grant money to help with the cost of the cameras.
 - A motion was made by Lou Bruce and seconded by Kenneth Martin to purchase the Flock cameras. The purchase is contingent on Kenton Heider approving the contract language. The motion for the purchase was approved.
- b. Pearland Outreach nothing is scheduled at the moment. Maybe towards the end of the year or beginning of 2024.
