This constitutes a first reading of said ordinance. It was moved by Councilperson Logsdon, seconded by Councilperson Lake to suspend the three reading rule, passed by six (6) votes. It was moved by Councilperson Lake, seconded by Councilperson Cassidy to adopt, passed by six (6) votes, the ordinance passed.
