PROFILE: ROBERTA "BOBI" PIKE-OATES, WOMEN VETERANS ADVISORY COMMITTEE

Bobi Oates didn't want to be an airplane mechanic; she wanted to be a cop. And she was ... sort of. After getting an associate's degree in criminal justice, she landed a job as deputy sheriff for a small county in Vermont, where she was raised. This was the '70s, when, to get to the big leagues of policing, women had to meet the same requirements as men.

"At 5-feet, 3-inches, that just wasn't going to happen for me," Oates says today.

So she took a friend's advice to get the same kind of challenge and see the world by joining the U.S. Air Force. She enlisted just as the Air Force was expanding its opportunities for women, Oates says, and based on her aptitude, they persuaded her to take one of the jobs available to the gentler sex: aircraft mechanic.



Lugging around heavy toolboxes and airplane parts and spending some 12-hour days on her feet took their toll on Oates. But where she was short on brawn, she had grit in spades. She recalls a flight chief telling her he didn't need female staff sergeants on his flight line, so she moved over to job control and continued to climb through the ranks. "I didn't think I'd make it four years," Oates says today. "I made it 23."

In 1999, she retired as a senior master sergeant. At the pinnacle of her distinguished career, she was one of the four people chosen to establish the 11th Reconnaissance Squadron of unmanned aerial vehicles at Creech Air Force Base. Oates is Nevada's Veteran of the Month for December.

Today, her mission involves a different type of maintenance: fixing the relationship between the U.S. military and its former female members. Nearly 10 years ago, she began volunteering with Women Veterans of Nevada; now she's on the executive board and the ceremonial team

Shingles is caused by the varicella - zoster virus. This is the same virus that gives you chicken pox. If you

have had the chicken pox, you're a high risk for shingles.

After you have the chicken pox; the virus moves from your skin to nerves along your spinal cord and stays dormant until your immune system is just weak enough to trigger the virus again. Once active, the virus spreads along your nerves to the skin. It forms a blistery rash that is painful, burning, itching and tingling. You may also get flu like symptoms of fever, chills feeling tired and headaches. These symptoms usually last 2-4 weeks. There is a vaccine available for those over 50 who have had the chicken pox. Ask your doctor if you would benefit from the vaccine.

A complication of having shingles is known as post herpetic neuralgia (PHN). This occurs when the shingles rash clears and the pain remains. This issue can remain a few days, months or years in some people. The pain can be very severe. Shingles can also cause complications with your eyes if it erupts on the face. Take the time to talk with your health care provider to see if you can take the vaccine to prevent this very painful virus.

BGEN VAUGHT ANNOUNCES RETIREMENT

On 4 January, BGEN Wilma Vaught announced her retirement as president of Women's In Military Service for America (WIMSA) Memorial. In her announcement, GEN Vaught stated, "I must say it has been an amazing and rewarding 29 years and one of the most gratifying times of my life. I knew, however, the time had come for the Foundation to transition to new leadership so that we capitalize on new technologies and strategies for business and communication and the enthusiasm and commitment of a younger generation of leaders. Like you, I want to assure our extraordinary Women In Military Service For America Memorial remains a viable center for learning about women's service to the nation and that there is a place where our individual stories are preserved and visible for generations to come."

Army Major General Dee Ann McWilliams, (Ret.), was introduced as her successor and is intimately familiar with the Foundation, having been a member of our board of directors since 2007 and serving as the board of directors vice chair since 2014. She took the helm as the Foundation president 1 January 2016.

GEN Vaught will be staying on at the Foundation with the title "president emeritus," assisting in the transition, working on a few projects and continuing to speak locally and around the country about the Memorial and the service of military women. MG McWilliams will be doing the heavy lifting and making decisions.

GEN Vaught is very proud of what has been accomplished in the 29 years since the Memorial was established. She stated, "Thanks to many of you, we changed the face of monumental Washington, adding military women to those the nation honors. Today, the Women's Memorial is one of only three major edifices in the entire nation to focus on women—and the only one to focus on military women! I believe we helped give military women a voice and a presence in discussions about our armed forces and finally in our history books. We established our own publishing arm, Military Women's Press, publishing a handful of books, our annual calendar and Women's History Month posters. Our world-class archive of artifacts and memorabilia related to women's service is the largest of its kind in the world, along with our growing oral history collection, which is supported by a corps of nationwide volunteers. These and our small research library have helped countless scholars, historians, journalists, television and movie producers and writers of all kinds tell the story of women's service."

The day consisted of musical performances, ceremonies, booths of information for veterans and culminated with a torch

processional to light the cauldrons on the Seekonk River.

Shirley was introduced to the crowd of over 200 gathered at the RI Statehouse and was presented with a Department of Defense Vietnam Veterans Commemorative Pin by Capt. Dennis Boyer, Commanding Officer of Naval Station Newport. The evening continued with a ceremony on the statehouse steps, a procession down to the basin and a concert by Navy Band Northeast and the 88th Army Band.

Organization Serves Female Veterans Of All Branches

BRANDON — Military women have served the United States since the American Revolution and share a unique sisterhood.

They're not exactly like their civilian counterparts. They must go where the job dictates, can be deployed around the globe and move more often.

Overseas, they may face frightening situations in which the threat of injury or death is the norm.

Their service is not always recognized, even by their male colleagues.

"Sometimes people will thank a man accompanying a woman veteran for his service while not acknowledging her service," said Navy veteran Jouay Koppari of Valrico, president of the Military Women of Tampa Bay Unit 55. "Even members of veterans' organizations often usher women veterans to the women's auxiliary rather than welcoming them in their organization."

Women of the various branches of the U.S. Armed Forces created individual associations to help with their unique veterans' issues.

For instance, in 1979, WAVES National was founded to support women who served in the U.S. Navy.

Recently, however, the number of members in several of these organizations have waned.

By early 2014, there were only eight women in the Tampa Bay WAVES Unit 55, which was chartered in 1988.

To meet the need for camaraderie and combat their dwindling numbers, in November 2014, WAVES National opened its units to women of all U.S. Armed Services

branches and changed its name to Military Women Across the Nation (MWAN).

The local group is now called Military Women of Tampa Bay Unit 55.

"The decision to adopt the name Military Women Across the Nation (MWAN) was [because] the acronym WAVES is associated with World War II Navy women veterans and is of little or no appeal to women veterans of today," said Brandon resident Jeannette Green. "We hope the organization will appeal to women veterans of all services and all conflicts, especially today's female veterans of Operation Iraqi Freedom and Operation Enduring Freedom."

The purpose of the Military Women Across the Nation is "to encourage patriotism, loyalty to God, country and family; perpetuate the honorable history of women in the military services; strive to support morale and assist all women veterans in need; seek opportunities for locating, communicating and associating with former military service women of Florida; and support other veterans organizations through community service and volunteerism," Green said.

"We are here to help and serve all military women — veterans and those currently serving — and advocate for them," said Riverview resident Catherine Gerolimatos, unit treasurer.

Military Women of Tampa Bay Unit 55 now has 30 members ranging in age from 30 to 96 who represent retired and active-duty women from the Army, Air Force, Coast Guard, Maritime Service and Navy.

They routinely participate in activities at and for the James A. Haley Veterans' Hospital, such as its Veterans Day Parade, fall fundraiser and December poinsettia distribution.

They visit area service clubs and help out with the Holiday Cards for Troops event at Center Place Fine Arts and Civic Association.

On Dec. 12, National Wreaths Across America Day, members of the Military Women of Tampa Bay Unit 55 placed wreaths provided by Wreaths Across America at the Veterans' Freedom Memorial at the Hillsborough County Veterans Memorial Park.

Military Women Across the Nation welcomes women who serve or have served honorably in regular or reserve components of the U.S. Armed Services, including the National Guard and Maritime Service.

Dues are \$25 per year. Life membership is \$30 for women at least 90 years old.

Military Women of Tampa Bay Unit 55 meets at 11 a.m. the second Saturday of each month from September through June at Hawthorne Village of Brandon Assisted Living Facility, 851 W. Lumsden Road.

Military Women Across the Nation President, Dassa Carvey was on-hand and participated in the ceremony by presenting the unit with their Charter and each member with a certificate.

There were several dignitaries in attendance to mark the occasion. Dr. Susan MacKenzie, Director of the Providence VA Medical Center was there. Dr. MacKenzie was appointed the Director of the VA Center in 2013 and has served as the Deputy Medical Center Director of the Boston Healthcare System, the Deputy Network Director of the VA New England Healthcare System, the Acting Director of VA Maine Healthcare System in 2012 and the Manchester VA Medical Center as her most recent achievements. Women Veteran Coordinator, Tonya Maselli McConnell, LICSW, BCD also attended.

The event also had a featured keynote speaker, Kim Ripoli who said, "It is the mission of organizations like MWAN to be the voice of other female veterans and to help them realize the benefits of participating in a veteran service organization." Ms. Ripoli is the Associate Director Veteran of Affairs of Rhode

Island. She manages the Division's operations, coordinates mission execution and oversees more than 220 employees in the three branches -Veterans Home, Veterans Memorial Cemetery, and Veterans Affairs. She entered Naval service in February 1988 and was deployed to Southwest Asia with the 1st Marines Expeditionary Force (1st MEF) in Saudi Arabia during Operation Desert Shield/ Storm. She was awarded the Navy and Marine Corps Achievement Medal for her actions during her deployment with Fleet Hospital 15. In September 1994, she joined the Navy Reserve, and affiliated with the Fleet Marine Force, 4th Force Service Support Group, 4th Medical Battalion, Surgical Company "A". In 2003, she was mobilized for Operation Iraqi Freedom. She received two Navy and Marine Corps Achievement Medals for her actions in Iraq. Additional overseas deployments include Operation New Horizon (2000), and Operation African Lion (2005). In July 2007, she was assigned to The Pentagon, in the office of the Assistant Secretary of the Navy for Manpower, Policy and Reserve Affairs. Her military decorations include the Navy and Marine Corps Commendation Medal (three awards), Navy and Marine Corps Achievement Medal (eight awards), Army Achievement Medal, Combat Action Ribbon, Presidential Unit Citation, Kuwait Liberation Medal-Saudi Arabia, Kuwait Liberation Medal-Kuwait, Iraq Campaign Medal, and various service, unit and campaign awards. Senior Chief Ripoli earned her Bachelor's degree from Rhode Island College, and Master of Arts degree from Salve Regina University. Associate Director Ripoli is the first woman in the history of Rhode Island to administer the Division of Veterans Affairs. During her address, she proudly displayed her service while wearing a Navy Ballcap.

The mission of the New England Military Women Across the Nation is to seek women who may not identify themselves as veterans. They have several priorities already identified to carry out their mission. As many units, they hope to establish a relationship with the Rhode Island Veterans Home, which is a 110-acre complex on Mount Hope Bay that provides quality nursing and residential care to Rhode Island war veterans. They also plan to participate in the Bristol, RI Annual 4th of July Celebration. The Celebration, the oldest in the country officially starts on June 14th, Flag Day and concludes with the 2.5 mile Military, Civic and Firemen's Parade on July 4th. With these goals, the tagline they have will prove to be a true premonition, "158 is Great!"

With the expanding identification in Rhode Island, the need for a second unit was necessary. that conducts weekly funerals at Boulder Cemetery for veterans who've died homeless or in the absence of loved ones.

"It's a way to make sure no vet passes without being honored and remembered," Oates says.

Based on that service, in the summer of 2014 Governor Brian Sandoval appointed her to the five-member Nevada Women Veterans Advisory Committee, a statewide group charged with identifying female veterans and advocating on their behalf. As the only member of the group in Southern Nevada, Oates represents the bulk of the state's population.

The new advisory committee faces enormous obstacles. Out of 21,000-plus female vets in the state, Veterans Services has located only 2,500. This matters, Oates says, because women are missing out on valuable benefits, such as education and health care.

For example, she says, "A lot of female vets are of child-bearing age, so they need access to obstetrics." One of the committee's recommendations that has already been implemented is the hiring of a full-time OB-Gyn at the Nevada Veterans Medical Center.

But a lot of work remains. The committee wants job and benefit applications changed to ask, "Have you ever served in the U.S. military?" rather than the current, "Are you a U.S. military veteran?" because women don't self-identify as vets. In June, the committee gave the governor a long list of recommendations for better communications, promotions and technology to spread the word about available benefits and services, and then keep track of those who respond. "Women have served," Oates says. "And they've all been volunteers, because women have never been drafted. Sometimes, we weren't even wanted, but we've always been there."

Now, she adds, they need to know the state and country they served are there for them.

About the award program

In 2011 the Veterans of the Month award was established by the Governor for men and women across Nevada who have gone above and beyond the call of duty, specifically with respect to volunteer work in support of veterans and the military.

"Men and women across Nevada who have made a significant contribution will have achieved excellence by going above and beyond the call of duty," stated Governor Sandoval in his presentation. "It will be an opportunity for all of us to shine a bright light on the work veterans continue to do for our nation."

Candidates are chosen for their assistance to former veterans, as well as for support ofactive duty personnel and the community at large.

After leaving military service, volunteer work performed for their peers and for those who may be less fortunate speaks to their character, their dedication, determination and willingness to unselfishly help others.

The program is managed by the Nevada Department of Veterans Services (NDVS) Submissions are reviewed and chosen by the members of the Veterans Service Commission (VSC) at its quarterly meetings.

Background: The VFW is committed to ensuring veterans' health care and benefits are equitable among the brave men and women who have worn our nation's uniform. In an effort to identify barriers women veterans face when accessing their earned veterans' benefits and services, the VFW has commissioned a survey of women veterans that will guide the VFW's policy priority goals for them. The VFW will analyze survey results and direct feedback from women veterans to make recommendations to VA and Congress on how to meet their needs.

Some of the wonderful benefits of belonging to a veterans' group are the surprises that come to the fore when the usual questions are asked: were you ever stationed at...; did you ever run across...; where were you when, etc.

Well, way back in 1964, as a very junior US Navy officer (O-2), I received unexpected, early transfer orders to a NATO command in London, England. Within weeks of my arrival, I met an extremely handsome and incredibly fascinating and urbane Royal Navy officer who was stationed at his Ministry of Defense. He, being the British Navy's expert on Mine Countermeasures and Mine Laying, frequently called me and visited my office, as I was NATO's coordinator for the associated NATO-wide Standardization Agreements (STANAGs). Over the next two years, he and I were required to attend meetings in other NATO nations, such as Greece and The Netherlands, where about 100 male military officers and I met to discuss details of these STANAGs. And so it began. The romance of the century. He was transferred to the south of England and four years later retired after an extremely successful 32 years in the Royal Navy. I was transferred to New Orleans shortly before his Navy retirement, but it was truly amazing how often his business trips to the United States just happened to coincide with when I was able to take leave. A few years later, he and I married and had an absolutely exciting and wonderful marriage of just over 40 years until his passing two years ago. As my husband, he had fully supported me during the last 19 years of my USN career, all the while taking on a variety of fun jobs no matter where we were stationed around the world. It was a perfect trans-Atlantic union!

So, in 1992, shortly after we retired to Pensacola, Florida, I became a member of the local Sea Service women's group. And I soon met Jackie Davis, a retired Navy Yeoman First Class (E-6). We started asking each other those questions and soon we were stunned to find that she, together with the woman officer detailer who was responsible for orders for us women officers (Commander Ruth Streeter), had actually written, 28 years earlier, my orders to London, England!!!! How fantastic!

New law allows retirees to transfer SBP when ex-spouse dies

A new law will prevent military retirees from losing Survivor Benefit Plan benefits when their ex-spouse dies before they do, by allowing the benefit to be transferred to a current or future spouse.

The 2016 National Defense Authorization Act provision will help an unknown number of people like retired Air Force Lt. Col. Harold Brown, who paid tens of thousands of dollars into his Survivor Benefit Plan for his ex-wife.

Retirees agree to pay a portion of their retirement pay into their SBP so that, when they die, the program will pay an annuity to their surviving beneficiary based on a portion of the retiree's pay.

Brown, one of World War II's famed Tuskegee Airmen, who survived being shot down near Austria and taken as a prisoner of war, has been in a battle with the Defense Finance and Accounting Service since 2013, when his ex-wife died of cancer.

At the time, he asked to transfer his SBP benefit to his current wife. Unbeknownst to him and a number of other retirees, DFAS had changed its interpretation of the law in May 2013 and refused to allow him to transfer the benefit.

That new interpretation affected situations in which SBP was awarded to an ex-spouse as part of a divorce settlement. DFAS said that, because the benefit would henceforth be considered part of the ex-spouse's property, the benefit "expired" if the ex-spouse died.

The new provision, which took effect on Nov. 25, fixes that problem for future retirees. It also applies retroactively to retirees who were previously unable to transfer their benefits after their exspouse died.

"I've been waiting and waiting and waiting," said Brown, 90. "When I got the news, I was quite delighted. This was just a terrible wrong."

Brown, who hired an attorney to help him pursue the issue, said that he's also happy for other affected retirees.

'There are others who are in much worse [financial] shape. ... It will make a tremendous difference to them," he said. The new law allows:

- · A military retiree who was married at the time of an ex-spouse's death, or who later remarries, to elect to provide SBP coverage to his or her current spouse. The request must be received by DFAS within one year after the date of the exspouse's death. For retirees who remarry after an ex-spouse's death, the request must be received within one year after the date of the marriage.
- A military retiree whose ex-spouse died before the effective date of the new law to elect coverage for his or her current spouse, regardless of whether the remarriage happened before or after the ex-spouse's death. The request must be received within one year of the law's Nov. 25, 2015, enactment.

Information was not immediately available on whether or when DFAS will have revised procedures in place to implement the new law, or whether retirees will simply be able to submit a standard DD Form 2656-6, as they did before May 2013.

Phil Odom, deputy director of government relations for the Military Officers Association of America, said that DFAS had allowed SBP transfers after the death of a former spouse from the time SBP was created in 1972 until the agency changed its interpretation of the law more than $2^{1/2}$ years ago.

Odom said the fact that DFAS made no public notice of the policy change rankled retirees, advocacy groups and some lawmakers.

"The remedy was essentially painless and did not threaten former spouses," he noted.

Brown did not hesitate to name his first wife as his beneficiary when they divorced in 1991.

"It seemed to me the only honorable thing to do," he said in an interview in March. "I would have done it even if it hadn't been for the court order. She was the mother of my two children. How was I to know cancer would catch up with her and she would die before me?"

If Brown had died before his ex-wife, the SBP would have paid a monthly annuity to her equal to 55 percent of his monthly retirement pay.

But after his ex-wife died, he said he simply wanted to name his new spouse, whom he married in 2010, as his SBP beneficiary.

With the passage of the new law, he said, "a terrible wrong has now been corrected. I would like to thank any and all people who played a role in the passage of this law."

The request for the change originally came from defense officials, said Dustin Walker, spokesman for the Senate Armed Services Committee.

"We thought it was common sense to ensure service members are able to pass their benefits on to their loved ones," Walker said.

In April, a DFAS official told Military Times that the agency had drafted potential legislation and provided a copy to defense personnel officials. Odom said that MOAA had brought the matter to the attention of defense officials and staff members of House and Senate Armed Services Committees.

The Military Coalition also adopted the issue as a goal to be remedied in fiscal 2016, Odom said.

VA Plans to Propose Expanded Disability Benefits Eligibility for Veterans Exposed to Contaminated Water at Camp Lejeune

WASHINGTON – The Department of Veterans Affairs (VA) announced today that it plans to propose expanded disability compensation eligibility for Veterans exposed to contaminated drinking water while assigned to Marine Corps Base Camp Lejeune.

From 1953 to 1987, water sources at the base were contaminated with industrial solvents that are correlated with certain health conditions. Secretary of Veterans Affairs Robert A. McDonald decided to propose presumptions of service connection for certain conditions associated with these chemical solvents following discussions between environmental health experts at the Veterans Health Administration and the Department of Health and Human Services Agency for Toxic Substances and Disease Registry (ATSDR).

"The water at Camp Lejeune was a hidden hazard, and it is only years later that we know how dangerous it was," said Secretary McDonald. "We thank ATSDR for the thorough review that provided much of the evidence we needed to fully compensate Veterans who develop one of the conditions known to be related to exposure to the compounds in the drinking water."

ATSDR determined that the drinking water at Camp Lejeune was contaminated with perchloroethylene, trichloroethylene, vinyl chloride, benzene and other petroleum contaminants from leaking storage tanks from 1953 to 1987. ATSDR also determined that prolonged exposure to these chemicals increases the risk of certain health conditions.

Based upon VA's review of current medical science and ATSDR's findings, Secretary McDonald intends to propose creation of a presumption of service connection for the following conditions:

- Kidney Cancer
- Liver Cancer
- Non-Hodgkin Lymphoma
- Leukemia
- Multiple Myeloma
- Scleroderma
- Parkinson's Disease
- Aplastic Anemia / Myelodysplastic Syndromes

The Secretary's proposal would also expand benefits eligibility to Reserve and National Guard personnel who served at Camp Lejeune for any length of time from August 1, 1953, through December 31, 1987. These personnel would be presumed to have been exposed to the contaminated water during their Reserve or National Guard service and, in appropriate circumstances, to have been disabled by such exposure during service, thus allowing them to qualify for VA benefits under the statutory definition of "Veteran." This would make them eligible for VA disability compensation and medical care for any of the presumptive conditions, and their surviving dependents would be eligible for dependency and indemnity compensation and burial benefits.

VA is working on regulations that would establish these presumptions, making it easier for affected Veterans to receive VA disability compensation for these conditions. While VA cannot grant any benefit claims based on the proposed presumption of service connection for these conditions until it issues its final regulations, it encourages Veterans who have a record of service at Camp Lejeune between August 1, 1953, and December 31, 1987, and develop a condition that they believe is related to exposure to the drinking water at the base, to file a disability compensation claim with VA.

VA will continue to grant claims for disabilities claimed to be associated with exposure to the contaminants that can be granted under current regulations and review of the evidence in each case. If a claim for service connection for one of the proposed presumptive conditions would be denied under current regulations, the denial will be stayed until VA issues its final regulations. VA will announce when the regulations are final and presumptive benefits can begin to be awarded. Veterans who served at Camp Lejeune for 30 days or more between August 1, 1953, and December 31, 1987, are already eligible to receive VA healthcare for up to 15 health conditions.
