

Waiver and Release of Liability, Covenant Not To Sue, and Hold Harmless Agreement

International Lama Registry, Inc.

2020 Gathering of Friends and Champions

Coronavirus Disease 2019 ("**COVID-19**") is a new respiratory virus that has been declared a worldwide pandemic. According to the Center for Disease Control ("**CDC**"), COVID-19 is thought to spread between individuals in close contact within six (6) feet of one another, through respiratory droplets from an infected person's cough, sneeze, or talking, and might be spread by those showing no symptoms. At this time, COVID-19 has no vaccine for prevention.

The CDC reports that COVID-19 symptoms may include fever/chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, and diarrhea.

National Cattle Congress, site of the Gathering of Friends and Champions (**the "Premises"**), and the International Lama Registry, Inc., shall take all precautions and preventative measures to limit spread and exposure of COVID-19 during the Gathering of Friends and Champions, including but not limiting to, implementing social distancing when possible, especially during exhibition of the livestock, requiring wearing of a mask by all observers and show participants, when possible, and continued encouragement of sanitary practices of hand washing and hand sanitizing.

However, despite all precautions taken by the Premises and the International Lama Registry, Inc., they cannot prevent exposure to, contracting of, or spreading of COVID-19 to individuals who enter onto the Premises to: observe the exhibition of livestock and activities at the Gathering of Friends and Champions, assist participants the exhibition of livestock and activities at the Gathering of Friends and Champions, are participating in exhibition of livestock or activities at the Gathering of Friends and Champions, or are working/volunteering for the Gathering of Friends and Champions. Further, due to the nature of the exhibition activities, the participants, may at times, be unable to wear masks or social distance during the exhibition activities of the Gathering of Friends and Champions.

AGREEMENT

I understand and acknowledge that by participating in the exhibiting of livestock and all related activities at the Gathering of Friends of Champions, entering the Premises as a non-participant or observer during the Gathering of Friends and Champions, or working/volunteering on the Premises during the Gathering of Friends and Champions, that I am accepting the inherent risk of the contracting of or exposure to COVID-19 and the possible risk of illness or death related to COVID-19. initial

I agree to remain updated on current CDC guidelines and recommendations regarding COVID-19, and I agree to follow and abide by sanitation practices and safety protocols recommended by the Premises and the International Lama Registry, Inc., and their employees, volunteers,

agents, successors and assigns, members, premises owners, insurers, directors, owners, officers, and affiliated organizations (“Released Parties”) while on the Premises. _____initial

I understand the nature of the risks, and I assume sole responsibility for my health and safety related to COVID-19 while on the Premises. I ASSUME ALL RISKS associated with my health and safety due to: my participation in the exhibiting of livestock or other activities on the Premises during the Gathering of Friends and Champions, presence as an observer or non-participant on the Premises during the Gathering of Friends and Champions, or working on the Premises during the Gathering of Friends and Champions regarding the COVID-19 pandemic. _____initial

I acknowledge that, to the best of my knowledge, I have not been exposed to any individuals testing positive or showing symptoms of COVID-19. I further acknowledge that, if I am showing any of the possible symptoms of COVID-19 (as stated above) or I am running a temperature, I will be asked by the International Lama Registry, Inc., to not participate in any exhibition of livestock or other activities on the Premises during the Gathering of Friends and Champions and to not be present on the Premises during the Gathering of Friends and Champions. _____initial

I further covenant not to sue the International Lama Registry, Inc., or Released Parties, waive all claims against the International Lama Registry, Inc., and Released Parties, and fully release and discharge the International Lama Registry, Inc., and Released Parties from any and all liability, claims, demands, causes of action, damages, loss, or expenses, which may arise out of: my possible exposure, infection, or spreading of COVID-19; any economic or non-economic losses due to, but not limited to, bodily injury, death, or property damage, sustained by me due to my participation in the exhibiting of livestock or other activities on the Premises during the Gathering of Friends and Champions, presence as an observer or nonparticipant on the Premises during the Gathering of Friends and Champions, or working/volunteering on the Premises during the Gathering of Friends and Champions, including claims for liability caused in whole or in part by the negligent acts or omissions of the International Lama Registry, Inc., and Released Parties. _____initial

I further agree to indemnify and hold harmless the International Lama Registry, Inc., and Released Parties for any and all liability, claims, demands, causes of action, damages, loss, judgments, attorney’s fees, or expenses, which may arise out of my possible exposure, infection, or spreading of COVID-19; any economic or non-economic losses due to, but not limited to, bodily injury, death, or property damage, sustained by me due to my participation in the exhibiting of livestock or other activities on the Premises during the Gathering of Friends and Champions, presence as an observer or non-participant on the Premises during Gathering of Friends and Champions, or working/volunteering on the Premises during the Gathering of Friends and Champions, including claims for liability caused in whole or in part by the negligent acts or omissions of the International Lama Registry, Inc., and Released Parties. _____initial

I agree that the signing of this Waiver and Release of Liability shall bind any successors, assigns, heirs, executors, personal representatives, administrators, legal representatives, and shall be deemed as a release, waiver, discharge, and covenant not to sue the International Lama Registry, Inc., or Released Parties. _____initial

I further understand that if I am under eighteen years of age, my parent/guardian must sign this Waiver and Release of Liability. _____initial

I further state that I have carefully read the foregoing Waiver and Release of Liability relating to COVID19 and know the contents thereof, and I sign this Waiver and Release of Liability with a full understanding of the consequences thereof. By signing this Waiver and Release of Liability, I hereby willingly and voluntarily choose to be a participant, non-participant, observer, volunteer or employee at the 2020 Gathering of Friends and Champions. _____initial
