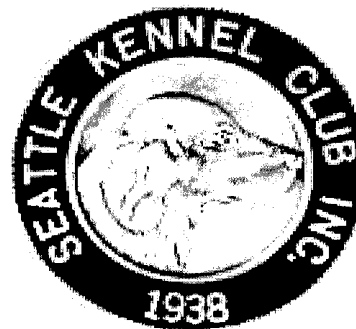

Directions: From Argus Ranch – turn left onto 212th Way SE and drive about 2 miles to the top of the hill to the ‘T’. Take a left and immediate right to stay on 212th Way SE and continue south for 3.2 miles to WA-164th/SE 436th St. Turn left for 2.0 miles and turn right on 244th Ave SE. Drive for 2 more miles to WA-410 (Enumclaw Buckley Rd) and turn right. Drive for 10.8 miles to the 166th Ave Exit and turn right onto Sumner Tapps Hwy E. Drive north for .3 miles and take a left onto 60th St. E Drive for .4 miles and the hospital is on the left.

Exhibitors should follow their veterinarians’ recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

ENTRY INFORMATION: One entry form may be used for all days

Entry Fee: \$19.00 for the 1st, 2nd and 3rd runs and \$12.00 for the 4th, 5th, and 6th entry per dog, per day. These include the required AKC fees of \$3.50 for the 1st, and \$3.00 for each subsequent run per dog/day.
Catalog: \$10.00 Please pre-order catalogs using entry form. A limited number will be available at the show.

ONLINE VS. PAPER ENTRY PRIMARY LIMITS

“The Seattle Kennel Club is accepting online entries through the R2AgilityOnline (www.r2agilityonline.com) system. During the first 48 hours after opening, the initial limit of entries designated as either online entries or paper entries will be as follows: Online Entries: 110 runs, remainder of limits by mail. If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either the online or paper limits accordingly.”

Paper entries received within 24 hrs. of the opening date & time must:

- 1) include postage or be metered;
- 2) be delivered by a multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.
- 3) **Express mail must be designated “no signature required”**

AWARDS: Ribbons will be awarded for Qualifying scores and ribbons for first through fourth place in each height division in each class. Rosettes for new titles earned will be awarded.

Regular Classes First Place: Blue **Second Place:** Red **Third Place:** Yellow **Fourth Place:** White **Qualifying Score:** Dark Green

A qualifying score is required for all awards. All awards must be claimed at the show.

MACH/PACH bars and Ribbons:

A MACH bar and ribbon will be awarded to all dogs that inform the trial secretary of the title possibility by closing. A “New Title” ribbon will be awarded to those recipients that have not previously informed the trial secretary. Help us make sure that we have enough fancy MACH awards available by telling us before closing so we can help you celebrate your big event !

Check your entry forms and confirmations:

Please be aware that AKC rules prohibit modification of an entry after the closing date/time. The ONLY allowed changes are for “move-ups” in class and those are required in writing by 6PM of the Monday before the trial. The trial secretary is not allowed to change jump heights, preferred vs. regular, or move down in classes after closing.

A preliminary email confirmation will be sent when the entry is received and processed. Make sure to check those confirmations closely and notify the trial secretary if you have corrections or changes before the closing date.

JUDGING SCHEDULE: Ring size is 100' wide x 90' deep - indoors on packed dirt.
Judging scheduled to begin at 8:30 AM each day, Friday MAY start later if the numbers allow it.

DOGS ELIGIBLE TO ENTER

This Trial is open to all dogs over the age of **15 months** that are registered with the American Kennel Club or are registerable breeds that have obtained ILP/PAL numbers from AKC or Mixed Breed registrations, except bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.

HEIGHT DIVISION

The following lists the required jump height for Preferred, and minimum height for regular agility classes. Judges only reserve the right to measure dogs at the trial who do not possess an official height card.

8 inches for dogs **11 inches** and under at the withers
 12 inches for dogs 14 inches and under at the withers
 16 inches for dogs 18 inches and under at the withers
 20 inches for dogs 22 inches and under at the withers
 24 inches for dogs over 22 inches at the withers
26 inches Dogs may be entered at this height at their owner's discretion

4" Preferred class
 8" Preferred class
 12" Preferred class
 16" Preferred class
 20" Preferred class

OBSTACLES: Obstacles shall meet the specifications for obstacles in the current edition of AKC Regulations for Agility Trials.

CLASSES OFFERED: See the chart above for classes offered. A complete set of rules for all classes is available from the **American Kennel Club, 8051 Arco Corporate Drive, Raleigh, NC 27617-3390**, or from the AKC web site (www.akc.org). It is the exhibitor's responsibility to enter their dog in the correct class. **The Trial Secretary cannot make any changes (except for move-ups as noted) after the closing date of the trial.** Be sure to check your entry form carefully and make certain you have entered the correct classes.

PREFERRED CLASS INFORMATION: You may not enter the same dog in preferred and regular classes in the same set of shows (weekend).

JUMP HEIGHT INFORMATION: Please indicate on the entry form if you have a height card (perm or temp), or need to be measured.

PREMIER CLASS INFORMATION: Dogs with an AX title are eligible to enter Premier Standard Regular. Dogs with an AX or AXP title are eligible to enter Premier Standard Preferred. Dogs with an AXJ title are eligible to enter Premier Jumpers with Weaves Regular. Dogs with an AXJ or AJP title are eligible to enter Premier Jumpers with Weaves Preferred. Dogs with Regular titles may crossover to the Premier Preferred level as noted above.

IMPORTANT INFORMATION FOR EXHIBITORS

THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.

ALL RIGHTS TO TELEVISION, VIDEOTAPE, ADVERTISE, PHOTOGRAPH, PROMOTE or otherwise exploit this event are vested in the Club, or in persons to whom assignments of such rights have been made in writing by the Club. All persons and animals on the show grounds at any time while the show is in progress, do by attending this show or participating therein, grant to the Club the right to photograph, televise, videotape, audiotape or otherwise use their likeness and voice in any manner without further release or consent. The Club is not responsible for the actions or products of the commercial vendors at this show.

Conditional, unsigned, incomplete, illegible, telephone or telegraph entries cannot be accepted. Entries not on official AKC form, or photocopies of AKC forms, **without the agreement attached are not acceptable.**

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, or in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of public enemy, or any other cause beyond the control of the organizing committee.

Confirmation of entry and schedule of judging time will be sent to the address on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, contact the Trial Secretary. Returned checks do not constitute a valid entry.

The **Seattle Kennel Club** assumes **No** responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee be asked to leave the Trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

The safety of dogs is of primary concern. By entering the Trial, exhibitors acknowledge that they are familiar with the rules and regulations of the sport, and that their dogs are familiar with and able to perform all obstacles safely.

Please clean up after your dogs on the show grounds and at your motel site. We want to retain these facilities for future events.

ONLY DOGS THAT ARE ELIGIBLE to be shown under The AKC rules shall be allowed within the show precincts.

OWNERS ARE RESPONSIBLE for errors in entry forms, regardless of who may make such errors.

MOVE-UPS: Move-ups after entries close must be submitted to the Trial Secretary in writing by **6:00 PM PDT on Monday, May 15th, 2017**. Include dog's call name, registration number, owner's name, class you are moving from, and class you are moving to. Send via mail, or email to r2agility@frontier.com. No phone move ups accepted.

Day-to-day move-ups will be accepted at the trial. Move-ups must be submitted in writing no later than 30 minutes after the last class of each day.

REFUNDS: A complete refund will be given, for any reason, if received before the closing date and time. After closing, a refund of the entry amount less \$5/run will be given for any bitch that comes into season, provided that written notification from a veterinarian is provided to the Trial Secretary by **Monday, May 15th, 2017**
No refunds will be given for amounts less than \$10

RING and CRATING INFORMATION

Take I-5, I-405, SR-167 to Highway 18 eastbound. Exit onto Auburn-Black Diamond Road eastbound.
Turn RIGHT onto SE Green Valley Road (just past Neely Mansion). Follow for about 7.5 miles.
Turn RIGHT onto 212th Way SE
Take First LEFT into Argus Ranch and follow drive straight ahead to Arena and signed parking.

From Hwy. 410 or WA 164 (Auburn-Enumclaw Hwy.)

Turn LEFT onto 244th Ave. SE (approximately one mile out of Buckley)
Go STRAIGHT at Light on SE 436th Way/WA-164. Go STRAIGHT at Stop Sign SE 416th St.
Go STRAIGHT at Stop Sign SE 400th St. Turn LEFT at Stop Sign onto SE 384th St.
Turn RIGHT at Stop Sign 212th WAY SE. Turn RIGHT at ARGUS RANCH Sign (just before Bridge)

AGREEMENT

I (we) agree that the club holding this event has the right to refuse entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine PartnersSM** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner? _____
