The May 2017 statement for Mayor's Court showing Village revenue of \$640.00 was presented to Council for approval.

Board of Public Affairs -

Mayor Reames reported on one large and several small sink holes along US Rt. 33 between the state fence and the highway. These holes are suspected to be caused by a broken or collapsed drain tile. According to the ODOT guidelines, the village is responsible for the drainage. A representative from ODOT district 7 was contacted and made aware of the situation and they have inspected the area and attempted to camera the line to identify the problem but encountered camera issues and will need to re-inspect at a later date. The ODOT representative also noted that if the village would supply the materials, they would be willing to supply the equipment and labor for the repair.

It was also noted that the ditch in front of the post office could be carved out and made a little deeper to increase the holding capacity and reduce flooding in that area.

Ms. Hendel provided council with a copy of the May 10, 2017 meeting minutes and reported on the May 24, 2017 meeting.

Lands, Building, and Facilities Report -

Council was presented with two quotes, Robinson Building (\$22,315) and Link Construction (\$25,650), for renovation of two offices and the vestibule in the municipal building. The committee made the recommendation to award the renovation project to Link Construction. The committee felt that the customer service, reputation, and prior construction projects suggests that Link would be the best choice for the project.
