There being a quorum, Mayor Simmons called the meeting of the Vienna City Council to order at 6:30 p.m.

Alderman Myrick made a motion to approve the Omnibus Consent Agenda consisting of the January 3, 2017 City Council Meeting Minutes and Warrant (\$55,064.23). Alderman Riddle seconded the motion. Roll call: Hill-yes, Riddle-yes, Myrick- yes, Owen-yes, Racey-yes, and Tuey- yes. Motion carried.

PUBLIC COMMENT

Edwin Bates was present to discuss with council a pending claim with the city for sewer connection. Wright said no action has been taken at this time because neither past nor present policy holder will accept the claim due to the date of loss. Bates had several questions for council including being reimbursed for sewer charges and plumbing bills as well as existing mold under the home. Discussion was had. Wright was directed to contact city attorney concerning the claim and reimbursements.

NEW BUSINESS

Alderman Hill made a motion to Amend an original motion on 9/20/17 for upgrades to city park restrooms an additional \$740.00 (TIF Funds). Alderman Tuey seconded the motion. Motion carried. Supt Racey had brief discussion on further work that needed to be done inside the restrooms including painting and petition walls.

Alderman Tuey made a motion to Authorize and Approve the Collective Bargaining Agreement between the City of Vienna, IL Public Works Dept and Laborers' International Union of North America and Laborers' Local 773. Duration Nov 1, 2017- October 31, 2019. Motion carried.

Alderman Racey made a motion to approve an Intergovernmental Agreement between the City of Vienna and Johnson County (Feb 1, 2018 to Dec 15, 2018) for Depot Coordinator position. The motion was seconded by Alderman Tuey. Motion carried.

CITY ELECTED AND APPOINTED OFFICIALS

Mayor Simmons informed council that ROC One located at 201 North 1st Street inquired of a Class A Liquor License to apply for a state license for gaming machines. Wright said their current B license would be up for renewal in June and a new class of license would have to be placed on the agenda for approval. Simmons had discussion with council.

Wright updated council on an email module to be installed in the utility billing system that would offer an email billing option to customers.

City Supt Racey stated a correction in the year of the truck purchased for public works dept. as a 2011Ford F150. Racey commented on recent meeting with Chad Sampson, Midwest Meter, on the installation of new gas and water radio meters. Racey mentioned a need to purchase a plasma cutter tool for gas meters to be placed on the next meeting's agenda. Racey mentioned hiring a part time seasonal worker for mowing in spring/summer months.

Fire Chief, Williams announced upcoming winter fire school training that four members from the department would be attending.

Alderman Riddle discussed interest in the city hosting an event for the Illinois bicentennial.

At 7:26 p.m. Alderman Myrick made a motion to go out of regular session into closed session to discuss Collective Bargaining Negotiations between the City of Vienna and Local Union 50 as per 5ILCS 120/0(c)(2).

At 7:37 p.m. Alderman Owen made a motion to resume the regular meeting. Alderman Myrick seconded the motion. Motion carried.

As there was no further business to discuss Alderman Myrick made a motion to adjourn seconded by Alderman Hill.
