- 2. Bring in proof of citizenship either a birth certificate (with government issued ID) OR a passport. If you are not a US citizen you must get TSA approval at www.fts.tsa.dhs.gov
- 3. Complete our Customer Data Sheet.
- 4. Read, Sign, and Submit Rental Agreement.
- 5. Schedule a time with your CFI to apply for a Student Pilot Certificate.
- 6. Prior to solo Get an FAA Medial Exam a First, Second, or Third Class.



# **Frequently Asked Questions**

#### How much does it cost to learn to fly and get a pilot certificate?

There are a lot of variables that affect the cost of learning to fly, including the frequency of flight lessons, weather conditions, the type of aircraft in which you are training, availability of scheduling, and individual aptitude. A rough estimate would range between \$10,000 and \$13,000 depending on the certificate being sought and student proficiency.

#### How long does it take to learn to fly and get a pilot certificate?

The same variables that affect the cost of learning to fly will affect the time it takes to earn your certificate. The FAA has established the minimum number of flight hours needed to obtain a certificate. Under Part 61 of the Federal Aviation Regulations, the minimum is 40 hours of training for a private pilot certificate. Part 141 minimum is 35 hours due to more FAA oversight and a stricter training syllabus. However, the national average is approximately 65 hours. These flight hours can be spread over a time span of several months to a year or more depending on various factors.

#### What are the differences between Part 61 and Part 141 flight training?

Part 141 programs have more FAA oversight, stricter training guidelines, and additional record keeping requirements. For the added regulations, approved 141 schools are allowed to reduce the minimum number of required hours of private pilot training to 35 hours, rather than 40-hours as required by Part 61 training. The Part 61 school, on the other hand, is able to be more flexible with training schedules and has the ability to tailor the curriculum to meet individual students' training needs. Either program must train you to pass the very same practical test.

#### What are the age requirements for flight lessons?

You don't have to be a particular age before you can begin to take flying lessons. However, with that being said, you do have to be at least 16 years old before you can solo an airplane (14 years old for operation of a balloon or glider), and 17 before you can be issued a pilot certificate. Therefore, it may not be particularly efficient from the standpoint of cost and flight hours to begin lessons too early. There is no age limit on taking flight lessons, so long as you can qualify for a 3<sup>rd</sup> class medical or meet the standards of the Basic Med program.

#### What does "ground" instruction mean vs. "flight" instruction?

There are 2 types of training involved with getting your licenses/ ratings. The first is "ground" instruction, which is essentially classroom/ book work; this is where you will gain aeronautical knowledge to apply in flight. Ground instruction can be done through online training programs, one-on-one instructor lessons, group ground sessions, etc. "Flight" instruction is the practical or hands-on part of flight training with the aircraft. This is where you will gain aeronautical experience and train in the aircraft according to FAA minimum standards.

# **PART 61 PROGRAMS**

### **Private Pilot Program**

- Be English Proficient read, write, & speak the English language.
- Be at least 16 years of age to solo and 17 years of age for your pilot's license.
- Provide proof of U.S. Citizenship OR apply for and receive TSA approval prior to training.
- Obtain a First, Second or Third Class Medical Certificate prior to first solo.
- Hold a Student Pilot License
- A minimum of 40 hours of training, consisting of:
  - o 20 hours dual instruction
  - o 10 hours solo (5 of cross country)
  - $\circ \ \ 3 \ hours \ night \ flight$
  - o 3 hours basic instrument work
- Average completion time is approximately 75 hours
- Pass the FAA written exam with a minimum of 70%
- Pass a Practical Test from FAA Designated Pilot Examiner Oral and Practical Flight portions.



# **Instrument Rating**

- Hold a Private Pilot Certificate
- Obtain a First, Second or Third Class Medical Certificate
- Proof of Citizenship OR TSA approval prior to training
- 50 hours of PIC cross-country
- 40 hours of actual or simulated instrument time
- 250 NM cross-country under simulated instrument conditions
- Pass the written exam with a minimum of 70%
- Typical completion time: 50 hours

# **Commercial Pilot Certificate**

- Hold a Private Pilot Certificate
- Obtain a First or Second Medical Certificate
- Proof of Citizenship OR TSA approval prior to training
- Must have at least 250 hours of total time
- 100 hours of PIC
- 10 hours instrument, 10 hours complex aircraft
- 300 NM cross-country
- Pass the written exam with a minimum of 70%
- Typical completion time: 250 hours



# What Type of Medical Do I Need?

It is important to understand the different types of medicals:

Medical Certificate:	First Class	Second Class	Third Class
Pilot/ License Type	Airline Transport	Commercial	Student Recreational Private
Duration of Validity	6 months if age 40 or older, 12 months if under age 40	12 months	2 years if age 40 or older, 5 years if less than 40 at exam
EKG Electrocardiogram	At age 35, and yearly after that	N/A Unless a doctor performed one.	N/A

A first class medical is required for pilots who exercise airline transport pilot (ATP) privileges; that is, those flying scheduled airliners and other pilots whose employers require this level of certification. A first class medical is valid for ATP privileges for twelve months for pilots under age 40. Pilots who are age 40 and older must renew First class medical certificates every six months. Pilots who are under 40, and the first class privileges expire after twelve months, the first class medical lapses to a third class medical.

A Second class is required for pilots who fly commercially—in operations such as crop dusting, delivering canceled checks, or carrying passengers or cargo for hire. The Second class medical is valid for commercial privileges for 12 months.

A Third class medical certificate is appropriate for student pilots, recreational pilots, and private pilots who fly for pleasure or personal business (but not for hire). A third class medical is valid for 60 months for pilots under age 40, and 24 months for applicants who are age 40 or older.

# What is the Cost of Training?

Training costs will be variable for each student. Everyone learns at different rates or may take a shorter or longer period of time to pick-up certain subject areas or flight maneuvers. Because these are variable factors, pricing will also vary per student, as our fees are primarily based off of hourly rates for the aircraft & instructor. Here are a few sample estimates for Private Pilot Training:
