Committee Reports:

ARC:

Proposed amendments to the ARC guidelines included: Use of temporary structures such as storage pods or dumpsters do not require prior approval if they are on the property less than 7 days. Window A/C units are prohibited on the front of a homeowner's property. Replacement to portions of gutters or downspouts must match existing ones.

Motion made to adopt and vote was unanimous.
