The Johnston County Volleyball Club (JCVC) believes our mission is to provide a positive and productive environment for players to train and grow as athletes while developing invaluable life skills. To enable success, it is necessary for the club to establish a code of conduct.

Player Code of Conduct

As a player, I understand that my team and I are the heart of the club. I realize that my behavior, mannerisms and attitude all have an impact on my team climate and ultimately my team's success or failure. I will strive to be the best version of myself, work to develop and succeed in the sport and act in manner that will bring respect to myself and all around me.

The following is a list of prohibited behaviors -

- Use/consumption/sale/distribution of tobacco products, vaping products, alcohol, prescription drugs without a prescription and/or an illegal substance
- Possession of a weapon of any kind
- Stealing or attempt to steal another person's property
- Attempt to cheat, or assisting another to cheat, during a competition, while competing or officiating
- Disrespect toward my teammates, coaches, referees, parents or opposing players
- Inappropriate physical contact with another player
- Failure to control your emotions, using foul or offensive language, gestures, threats and/or physical violence
- Failure to disclose to the club if I have been released from another club at any time in my career
- Misuse, abuse or destruction of property
- Littering, including leaving trash behind at practice or competition venues
- Unexcused absence from a club function, practice or competition
- Unexcused late arrival at a club function, practice or competition
- Leaving a competition venue, hotel or other team meeting location without first being released by a coach
- Violation of curfew
- Acting in an irresponsible manner that could or did lead to endangerment of yourself or another
- Failure to comply with content included in the JCVC Player & Parent/Guardian Handbook

I understand that violation of any of the above rules may result in disciplinary action, up to and including immediate release from the club. In the event that I am released from the club, I understand that my parent or guardian is responsible to all club dues payments in full.

Parent Code of Conduct

As a parent or guardian, I understand that my actions are just as important as my player's actions. I realize that my player's actions and attitude are likely to be a direct reflection of me. I will strive to be the best version of myself, learn the rules of the sport and do my part to insure success of the team.

The following is a list of prohibited behaviors -

- Use/consumption/sale/distribution of prescription drugs without a prescription and/or an illegal substance
- Attendance of any club function while under the influence of alcohol or any illegal substance
- Stealing or attempt to steal another person's property
- Disrespect toward players, coaches, referees, parents or opposing players
- Approaching a player (including your own player), coach or referee with negativity during a competition
- Approaching a team huddle or bench after the start of completion without first being asked join by a coach or staff member
- Engaging in belittling or demeaning behavior directed toward players, coaches or officials
- Failure to control your emotions, using foul or offensive language, gestures, threats and/or physical violence
- Failure to disclose to the club if my player has been released from another club at any time during their career
- Misuse, abuse or destruction of property
- Littering, including leaving trash behind at practice or competition venues
- Acting in an irresponsible manner that could or did lead to endangerment of other club members
- Inappropriate contact with a minor athlete
- Coaching from the sidelines

I agree to allow JCVC to use my player's image and profile information for marketing purposes, to include posting on club website and club recruiting and marketing material. We understand that the club will not share personal information beyond that included in my player's public recruiting profile outside the club without prior permission.

I agree to indemnify, defend and hold JCVC, it's staff, coaches, players and other representatives harmless from all claims (including claims based upon the alleged negligence of the club, it's coaches, staff, players and other representatives), liabilities, suits, losses, damages and expenses (including court costs) arising out of this agreement.

I certify that I have read and understand the rules provided above. I also certify that I have read and understand the JCVC Player & Parent/Guardian Handbook.

I understand that violation of any of the above rules may result in disciplinary action such as being banned from attending club events and/or competitions, release of my player from the club and/or notification to local authorities. I understand, regardless of my standing with the club upon any violation of this agreement, I am responsible to all club dues payments in full.
