TODAY'S MEETING

The October 11th KCPR meeting once again included long discussions regarding what strategy to pursue in regards to seeking a benefit increase and how to combine that with the real fear that the underfunding would intensify because of the recent Supreme Court decision on school funding, and we have also learned that the dreaded discussion over a reamortization plan would once again surface. The outcome of this would be the ultimate example of "kicking the can down the road." One fact is painfully obvious! If the underfunding doesn't stop, a benefit increase will be extremely difficult to achieve.

Some GOOD NEWS

- 1. The Silver Haired Legislature recently passed two resolutions, one supporting a COLA for KPERS recipients (Resolution 3504) and a resolution asking the legislature to stop underfunding KPERS(Resolution 3503).
- 2. One of our sister coalitions KKP (Keeping the Kansas Promise) is affiliated with NPPC (National Public Pension Coalition) which will FUND a KPERS SOCIAL MEDIA CAMPAIGN promoting no further underfunding.
- 3. KKP will also be funding a reception following the February 5th RALLY in support of KPERS_for those who have to work during the time of the rally.

IMPORTANT DATE

At this day and time, the KCPR Rally in support of KPERS is scheduled on Monday, February 5, 2018. The back-up (weather date) will be Wednesday, February 7. The event is scheduled from 10:00 am to 11:30 am in the Rotunda in the Capitol in Topeka. [This date is yet to be officially confirmed, but we are fairly confident that this date will be officially confirmed.]

General Election – November 7, 2017- THE ADVANCE VOTING PEREMITERS MAY VARY FROM COUNTY TO COUNTY. CHECK ON THESE LOCALLY!! Check your area for sure, but Advance Voting likely begins Oct. 23, 2017

Registration books close - last day to register (K.S.A. 25-2311(a)(3))

[Be sure you are registered!! Name change, address change, party affiliation change will require reregistration!]

July 18, 2018

Advance voting by mail begins - 20 days prior to Election Day (K.S.A. 25-1123(a))

July 23, 2018

Advance voting in person begins (K.S.A. 25-1122(g))

[THE ADVANCE VOTING PEREMITERS MAY VARY FROM COUNTY TO COUNTY. CHECK ON THESE LOCALLY!! – The dates listed above are Johnson County Dates!!]

August 6, 2018

Advance voting in person closes (12 noon) (K.S.A. 25-1122(g)) Filing deadline for Independent nominations (12 noon) (K.S.A. 25-305(b)) Filing deadline for District Court Judges Retention of Judges (12 noon) (K.S.A. 20-2908)

August 7, 2018 FALL PRIMARY ELECTION

First Tuesday in August in even numbered years (K.S.A. 25-203, K.S.A. 25-2502(b))

August 13, 2018

Primary Canvass (K.S.A. 25-3104)

September 1, 2018

Deadline for questions to be placed on the General Election ballot Deadline for State Board of Canvassers to meet (Primary) (K.S.A. 25-3205)

September 7, 2018

Filing deadline for Supreme Court and Court of Appeals judges to file for retention Kansas Constitution Article 3 Section 5(c) (K.S.A. 20-3006(a))

October 16, 2018

Registration books close - last day to register (K.S.A. 25-2311(a)(3))

October 17, 2018

Advance voting by mail begins - 20 days prior to Election Day (K.S.A. 25-1123(a))

October 22, 2018

Advance voting in person begins (K.S.A. 25-1122(g))

November 5, 2018

Advance voting in person closes (12 noon) (K.S.A. 25-1122(g))

November 6, 2018 FALL GENERAL ELECTION

Tuesday after the first Monday in November in even numbered years (K.S.A. 25-101, K.S.A. 25-2502(a))

November 12
