

4/9/2018

Sgt. Yonley received a call in reference to a two-car accident, on State Route 7 in Hannibal. The MCSO investigated the call and the Sardis Fire and EMA evaluated the injured.

Deputy Barton was on TH Road 6 in Jackson Township when he came across a vehicle parked on the roadway. After further investigation, this part of TH Road 6 was in Washington County. A unit from WCSO investigated the complaint.

Sgt. Smith responded to a residence on Mechanicsburg Road that reported property damage. Sgt. Smith observed where a truck drove into a field several times leaving ruts and damaged a hay field. Extra Patrols were requested in the area.

During the execution of the current search warrant (Today) Tammy Forshey and Joseph Blevins were again arrested and transported to the Monroe County Jail on charges of 4 counts of Trafficking in Meth. (1 F-3 and 3 F-4's), 5 counts of Possession of Meth (5 F-5's), Possession of a Schedule III drug (m-3), and 3 counts of Weapons Under Disability (3 F-3). To summarize, the Monroe County Sherriff's Office recovered Methamphetamines, Schedule III drugs, \$876.00 Cash, 3 Firearms, Numerous drug related items, 2 Motor vehicles, and 2 ATV's.

Deputy Blamble arrested Kevin Ferrell for a child support warrant, he was transported the MCSO Jail.

Deputy Blamble spoke with a female about a possible child endangering. Investigation pending.

Sgt. Peska spoke to a male that was being scammed on Facebook. He was advised to not send money or give personal information out. No report taken.
