PA Lifesharing Coalition Meeting Minutes 8/21/14

- Carrie to send letter to Patti McCool and Matt Jones on behalf of LS Coalition regarding
 difficulties about time it takes to work through the system of Self-Inspection Tool of new LS
 home and the PROMISe approval process. Specific examples cited from across Commonwealth
 in which homes were not able to open for services for 4-6 months. This is unacceptable and can
 jeopardize an individual's LS placement.
- <u>Focus group update w/Maggie</u>. Discussed aforementioned issue with Jenn Fraker. Fair Hearing and Appeal process may be utilized. Emergency respite can be utilized for 30 days. After that, providers are in violation. Maggie will upload Fair Hearing process to PA Lifesharing website.
- Jen Fraker to coordinate meeting with Matt Jones, Chuck Frick, Patti McCool, and LS focus group to address this issue
- ODP Chapter 51 states that providers should not begin services until authorization is received.
- DOL final rule states that substitute care will probably turn into an employee relationship. In cost reports for agencies, sub care should be declared under Schedule D. There will be extra money for what is being called "relief." If providers have to increase their stipends, they would note extra costs. We won't see the results of this for the next 2 years.
- Maggie suggested that Lifesharing be removed from the residential services definition so that providers would be able to provide respite services.
- Affordable Care Act-If we have employee that works more than 20 hours/week, possibly 30 hours, providers must provide health insurance. Agencies should check with their HR departments.
- Governor Corbett's budget has been approved; however, we do not know if the Lifesharing incentive has been approved.
- ODP to send a memo indicating that the \$5,000 start up may be approved with parameters around the money
 - ≈ Time constraints, i.e., a person may have to remain in Lifesharing for at least 6 months in order to be granted the money
- Numbers of people in Lifesharing have slightly decreased. LS families and individuals are passing away and/or have increased medical needs which are difficult to support in a LS home.
- Jen Fraker is to get details from HCSIS or may use Survey Monkey to get a more accurate picture of why LS #'s have decreased
- ODP should be encouraged that if Lifesharing is part of the state's initiative that ODP should be addressing some of the barriers to Lifesharing. ODP's legal team should be looking at these issues.
- For many years, PAR has been advocating for parents to be permitted to become LS families.
 According to 1927 Article 10 of welfare code, this is prohibited, so PAR will no longer pursue this
 issue. Families can only provide Habilitation services. #241 is in the PA House Finance to review
 families and Home and Community Habilitation. There is an analysis of who can and cannot be
 paid.
- NASDAS information: Lawsuits are starting against DOL regarding companionship exemption
- Lifesharing Conference update
 - Room monitors and volunteers needed to be available for at least one session (discuss at regional meetings)

- Carrie Kontis from Barber Institute and Mel Knowlton from PAR provided highlights for the DOL Final Rule.
 - ≈ Final rule came out 1/16/14 and became effective 3/17/14
 - ≈ CMS is looking for increased integration for waiver participants.
 - ≈ OLTL-6/30/14 amendment for 3 waivers; consolidated waiver, PFDS, and adult autism
 - ≈ From the Final Ruling, pay close attention to pages 26 & 96.
 - If someone goes to hospital, ODP has said providers cannot use waiver money for personal care or medical needs of the individual.
 - Pg. 26-discusses conditions in the hospital
 - Pg. 96-discusses conditions in the ER
 - Providers will not get paid during these times
 - ≈ Setting Must Meet Qualifications
 - Must be integrated in the community
 - Affects pre-vocational settings and possibly residential settings, i.e., people living on a farm or in a rural setting
 - Unclear about what CMS is looking for
 - Sample questions/issues to ask/review at public forums:
 - What is the future of sheltered workshops?
 - What is to be used for competitive wages?
 - Request clear definitions
 - Discuss lease agreement and how it affects Lifesharing
 - Individuals have ability to come and go and have visitors at any time and must have keys to their home. Can these issues be addressed in Assessments and ISPs under Health & Safety?

- Provider agency owned homes—what if people want to remain in home but choose another provider?
- If agency owns home, lease must adhere to landlord/tenant guidelines
- Look at eviction rights, i.e., 5 days for an appeal—What about if there is imminent physical risk to families? Cannot wait for 5 days, sometimes requires immediate removal
- Individuals must have access to food at any time—What about diabetes or other issues? Can this be addressed in Assessment and ISPs?
- PAR's recommendation is that ODP involve stakeholders in writing of regulations or bulletins. (Precedence in mid-80's in which stakeholder group wrote early intervention regs).
