TENNIS COURT MAINTENANCE DESCRIPTIONS

Fast dry soft courts are designed to be maintained on a <u>daily</u> basis. This is particularly important in the Hamptons where many of the courts are built without a stone base and/or with only 8-10 tons of soft court material rather than 40 tons. (Do you see dirt 1-2 inches below the surface and/or ant holes?) In order to ensure the safest and best possible playing surface, we highly recommend at least a twice-weekly maintenance contract. Some companies charge for weekly maintenance the same price we charge for twice as much service! The twice-weekly Basic Maintenance contract is the best value for tennis court maintenance in the Hamptons!

BASIC MAINTENANCE CONTRACT:

Basic maintenance includes a once weekly rolling, sweeping, lining and removal of debris from court. Additionally, we will apply up to $\frac{1}{2}$ gallon of weed killer once per summer, as well as up to $\frac{1}{2}$ ton of fast-dry soft court material and 100 pounds of calcium chloride. The Basic Maintenance Contract begins the week of May 19, 2008 and ends on Aug. 31, 2008.. Price: \$1260 + \$110.25 tax = \$1370.25

Court closing is a necessary part of court maintenance. It includes removal of all tapes, nails and nets. If it is not done in the fall, a Spring Closing charge will be applied the following season (see below).

INFORMATION REGARDING RESURFACING

Please note that the water must be turned on prior to our visit. Please have your sprinkler company check to make sure the sprinklers are working properly. All lines, nets and nails must be available. If not, there will be a return fee of \$250.00. If your court has not been closed (tapes picked up, nails removed) a Spring Closing will be required for a fee of \$125.00.

Excess weed growth which requires additional weed killer or additional manpower to remove will be billed at \$35.00/manhour for foreman and \$28.00/manhour for each additional worker plus the cost of the weed killer (\$48.00/gallon). All additional work (including hanging windscreens) will be charged at \$35.00/manhour for foreman and \$28.00/manhour for additional worker plus cost of materials. In most cases, we can hang windscreens within two manhours.
