Meeting called to order by Supervisor Chandler at 6:30 p.m. The Pledge of Allegiance was recited.

Motion by Missler to approve the agenda. Support by Wiederhold. Motion carried.

Motion by Wiederhold to approve the January 21st 2019 regular meeting minutes. Support by Curley. Motion carried

Treasurer Report: Wiederhold

Any unpaid taxes have a 1% penalty and are payable at the township until February 28th. After that date, they will be turned over to the Monroe County Treasurer for collection.

Total monies in all accounts is \$2,098,425.35.

Motion by Curley to accept Treasurer’s Report. Support by Missler. Motion carried.

Clerk Goodin presented checks. Motion by Wiederhold to approve checks #31318-#31360 in the amount of \$160,878.60. Support by Curley. Motion carried.

1. Emergency Reporting – annual subscription fee of \$2,640 with a one-time set up fee of \$960.00.
2. ImageTrend – Annual fee of \$3,375.00 with a webinar training fee of \$700.00.
3. ESO Suite – annual fee of \$2,985 with webinar fees of \$495

Supervisor Chandler stated that he spoke to Ida Township’s Chief and they are satisfied with Emergency Reporting. Motion by Wiederhold to subscribe to Emergency Reporting at an annual subscription fee of \$2,640 with a one-time set up fee of \$960. Support by Missler. Roll call vote: 5 yeas, 0 nays.
