Minutes of March 4, 2019

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Jed Lamb. Also present were Walter Rollin, Robert Holmes, Dennis Finkel, Carl Strekely, Chief Wetherbee, Frances Rollin and Sheila Lanning.

Motion by Holmes with a second by Rollin to approve the minutes of February 18 regular scheduled meeting as written. Roll call: 3 yeas.

FINANCIAL REPORT: *Motion* by Rollin with a second by Holmes to approve the February financial reports showing revenue to date of \$22,809.70, expenditures to date of \$43,067.83 and cash balance of \$252,753.20. Roll call: 3 yeas.

PAYMENT LISTING: Checks 8589- 8621 and expenditures totaling \$12,026.44 were approved for payment.

RESOLUTIONS AND ALLOCATIONS: *Motion* by Lamb with a second by Holmes to authorize *Resolution 2019-32* the Lorain County Chip and Seal program for 2019 and authorizing up to \$60,000.00 for the various roads selected to chip and seal. If the bidding comes in above the Trustees will re-evaluate. Roll call: 3 yeas.

COMMITTEE REPORTS-

WATER BOARD- Quarterly meeting this week, maintenance on painting awarded to MK Painting for \$118,000.00. Holmes asked why a lower bid was not selected. Lamb responded that there were exceptions under certain conditions in the other bids. Holmes asked how many taps were put in in 2018, Lamb thought approximately 2000.

LORCO- none

AMBULANCE- SOG is still going through them. Who pays what in Ambulance use, if a resident has no insurance, working with collection agency to help them. If you are a resident and your Medical insurance billed but some cost is under your unpaid deductible than the resident pays.

FIRE- Chief Wetherbee in attendance to give a re-cap of 2018. Runs were up last year and this year not better with 566 so far. Already a 30% run increase. Last weekend calls on trees over roadways. Pittsfield leads in runs last year followed by assisting Central LC Ambulance. Hired seven and lost one employee last year. Optional training for new hires is either EMR (Emergency Medical Responder) or EMT (Basic 160 hours). Milestones in 2018 included three people reaching 20 year service, four people have 30+ years services. Current rooster is 32 members. Discussion on training, capital acquisitions and an expansion of \$600,000.00. Turn out gear has a ten-year shelf life. Blue reflectors in the roads mean a water fire hydrant is near.

OPWC- none

SWAC- Griggs Road project: two bid books were taken out for the project.

ZONING BUSINESS/NEWS- Finkel presented a copy of the Violation letter being sent to Mr. Freeman regarding clean-up.

Lamb would like to ask if money from Office of Aging that went to Thrive could go back to Office on Aging.

CEMETERY- Lanning confirmed that Cemeteries are registered.

ROAD AND EQUIPMENT AND MAINTENANCE- Finkel talked to Melway about the deterioration of Baker Road by Clar Mar. Getting information on a newer backhoe with asking price of \$19,000.00. Finkel thinks we could selling our backhoe for \$12,000.00 and move up several model years. Discussion on where to pay for the newer backhoe.

RECYCLE- Consensus to set May 17 & 18 as Spring Dumpster days, 9:00 – 3:00.

TRASH CONSORTIUM- none

SHERIFF- 25 incidents in February.

OLD BUSINESS-

Zoning Office Sign- Drawing given to Lamb.

Land Use Plan- Lyn Ickes stated the first meeting was Saturday March 2. There attended. All went well with people given maps of the Township to take home and sketch in what they think the Zoning should look like in the future. Next meeting is March 16^{th} at 10:00-noon.

Landfill- Lanning asked Chief Wetherbee to tell Bill Brown a monitoring sample is needed in March for the EPA.

File Cabinets- cabinets are painted and reassembled.

NEW BUSINESS-

Commissioners sent 2019 CDBG grant package. Public Comment of Solid Waste Plan Update is through March. Received signed and executed copy of Joint self-insured Health Care Plan from the County. Certified letter from LC Recorder reiterating the need to file Zoning Amendments picked up by Lyn Ickes because USPS could not deliver. March vaccine locations and Senior breakfast posting to the Web. OTARMA appraisal company visited today and took photographs. Grant application for Township road signs given to Finkel. March 14 is Health District Advisory Council. ODOT training opportunities given to Finkel. LC Soil and Water Winter/Spring letter posted on the web. Fair Board authorized selling of beer at the Fair. Lamb stated the vote was unanimous and they are trying to make it controlled.
