Regardless of your politics -- this (letter in the email forwarded below) is more evidence of what I wrote you about earlier --- these extrajudicial killings, military-medical-industrial rise threatening our liberty (as Truman and Eisenhower warned) is a reality and one we must turn back for the sake of our Great Nation. President Trump -- you know that "we have a lot of killers" (O'Reilly interview 2.5.17) -- what are you going to do about this? We are no longer "innocent", but we do want to get back to the foundation of Our Constitution, follow due process, and the rest of the important rights Our Founders strived for and envisioned. We are NOT like the rest of the World and


if we continue on this path, do not demand investigation, justice and due process for those killed and their killers, and halt this horrific reality, we will rapidly descent and our freedoms stifled beyond any semblance of our constitutional rights.

If you read the 40 pages (email 1/3), my concern was actually for those on the left who are killers (including some at UM [via "medicine"] and the medical industrial complex). It is clearly not a partisan or biased endeavor. Those with high-level access and lethal skill-sets must be closely monitored in perpetuity and this "trend" recognized for the unconstitutional anarchy and horror it is and banned. As far as medicine and that power over life and death, (a doctor dismembered Khashoggi [apparently ~~he~~ was present for the killing in any event] -- a doctor at UM said some vulnerable people are just put on a "morphine drip" and that's it -- not as horrific, but murder nonetheless -- I was threatened in a vile way using medicine and I have no doubt such horrors are committed) -- My labs have been deliberately altered, obviously hardly even possible results ... **I’m an ex-Army Ranger, who has access to classified information about everybody in  
this country, because I do free-lance work for the CIA; DNI; DOJ; FBI, and NSA.**

**So, I think I’ll pay you a visit soon.**

**What do you think will happen then...?!**

**Trust me — it will be the worst day in your life...!**

**See you soon....**

An ex-Army Ranger**

I received this threat in the mail last month and **the FBI is actively investigating  
it**. The fact is, more than two dozen people have gone to jail in connection with  
various plots to blow up our building or kill Morris Dees, our founder, because of our  
work exposing and suing violent hate groups...”
