### Registration Form

**Registration Fee:** \$40 per person. Make check or money order payable to 'Ride 4 Trails' and mail to: **Ride 4 Trails, P.O. Box 227, Terlingua, TX 79852.** All riders must check-in at event headquarters. Same day registration is permitted at Big Bend Resort and Adventure meeting room until 11 A.M. on Saturday.

**Acknowledgement and Assumption of Risks:** I acknowledge that Big Bend Resort and Adventures (hereinafter referred to as the "Resort"), and its personnel have informed me that the Ride 4 Trails activity is not without risk. I fully understand the nature and any physical demands of the activity and the inherent risks, hazards and dangers to myself, property and third parties associated with engaging in the activity. I am aware that engaging in the activity could entail risk of injury or death to any participant and/or damage to personal property. I AGREE TO ASSUME AND ACCEPT FULL RESPONSIBILITY FOR THE INHERENT RISKS OF PARTICIPATING IN THIS ACTIVITY. Engaging in the activity under the influence of alcohol, drugs or other controlled substances greatly increases the risk of injury and I understand that it is strictly prohibited.

My participation in the Activity is purely voluntary, in reliance upon my own judgment and ability, no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks. I certify that I am fully capable of participating in the Activity. I assume all risk of loss and full responsibility for myself, including minor children, for bodily injury, death and loss of personal property and expenses thereof as a result of the inherent risks and dangers and of my negligence in participating in this activity.

**Liability Waiver:** I hereby release and forever discharge on behalf of myself, my heirs, assigns, personal representatives and estate and for all members of my family and their representatives (collectively, the "Releasing Group Members"), Forever Resorts, L.L.C., (including Big Bend Resort and Adventure, Ride 4 Trails Planning Committee, and all other persons or entities controlling, controlled by or under common control with, Forever Resorts, L.L.C.), their principals, directors, officers, agents, employees, representatives, members, stockholders, owners and volunteers, their insurers and every land owner and/or governmental agency upon whose property the Activity is conducted and their insurers, if any (collectively, the "Releasees") FROM ANY AND ALL LIABILITY OF ANY NATURE, FOR ANY AND ALL LOSSES, DAMAGES, INJURY OR HARM (INCLUDING DEATH) TO OR BY RELEASING GROUP MEMBERS, AS A RESULT OF PARTICIPATION IN THE ACTIVITY AND/OR ARISING IN CONNECTION WITH THIS EVENT, WHETHER ARISING WHILE ENGAGED IN COMPETITION OR PRACTICE OR PREPARATION THEREFORE, OR WHILE ENTERING OR DEPARTING FROM SAID PREMISES OR WHILE PARTICIPATING OR ASSISTING IN THIS EVENT. I further agree on behalf of myself and the other Releasing Group Members to indemnify, defend and hold harmless the Releasees from any loss, damage or liability, including attorney's fees and other costs, that result from claims, demands, or causes of action that are related in any way to losses, damages, injury or harm (including death) arising from participation in the Activity, the Resort's related services or facilities, my property or the use, navigation or operation of the same in the Activity or otherwise.

**Agreement to Arbitrate:** If a dispute arises under this Agreement which cannot be resolved by good-faith negotiations, the parties agree to waive OUR RESPECTIVE RIGHTS TO TRIAL BY JURY AND RESOLVE OUR DISPUTE BY SUBMITTING THE SAME TO BINDING ARBITRATION in accordance with the commercial rules of the American Arbitration Association. In the event arbitration is necessary, the prevailing party shall be entitled to recover costs and expenses of the arbitration, including, but not limited to, attorneys' fees, administrative costs, and any costs and attorneys' fees incurred in executing on or enforcing the arbitration award.

**Photo Release:** I hereby authorize, Ride 4 Trails, Big Bend Resort and Adventure, and DJ Sanders the right to make, use, re-use, and publish any photographs taken of me during RIDE 4 TRAILS event for use in printed publications, website, and advertisement for Ride 4 Trails or Big Bend Resort and Adventure. I acknowledge that since my participation in publications, websites, and advertisement produced for Ride 4 Trails and Big Bend Resort and Adventure is voluntary, I will receive no financial compensation. I hereby disclaim any right to the copyright in any such works and assign any rights that I may have in such works to Big Bend Resort and Adventure and DJ Sanders.
