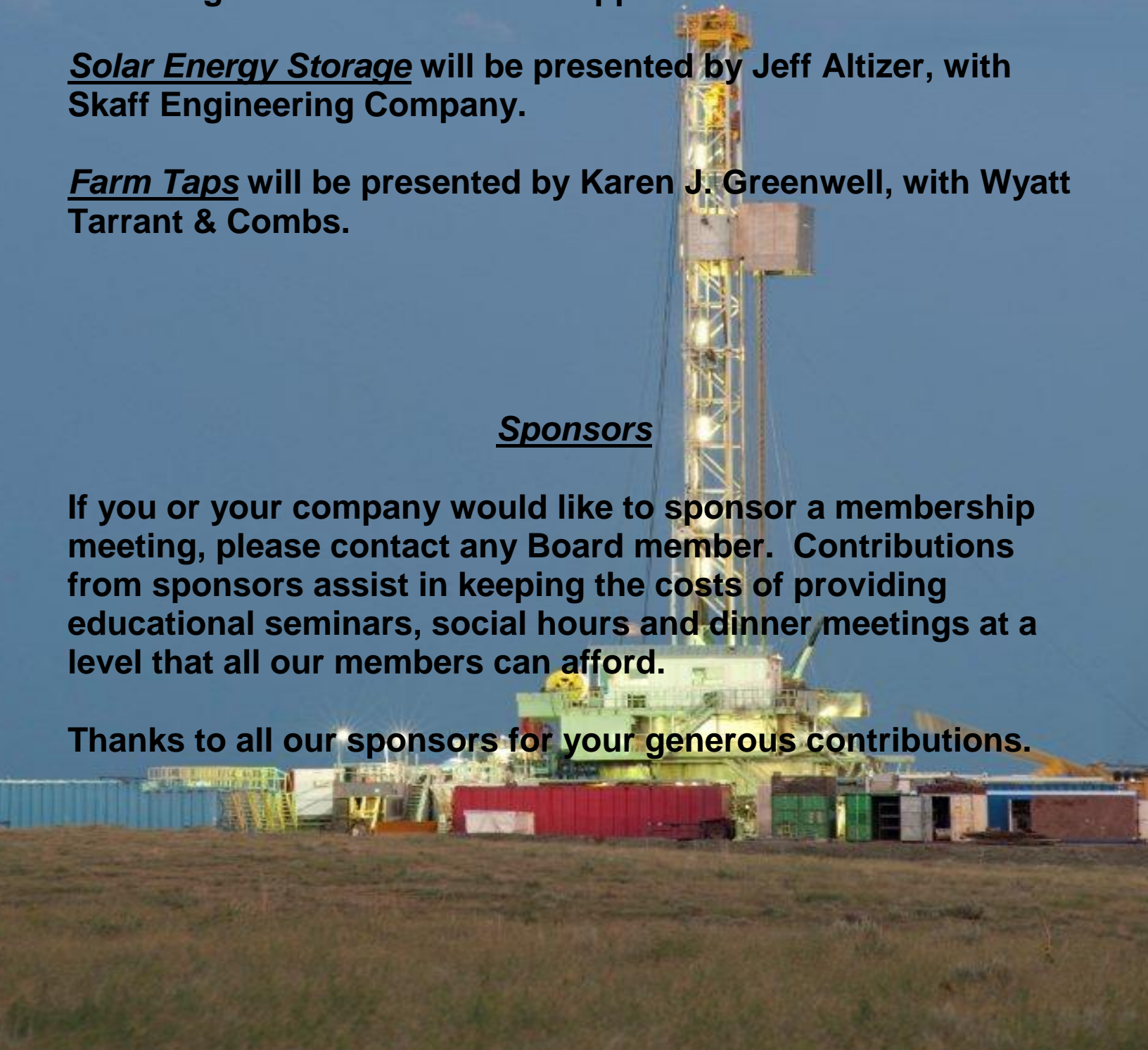
Solar Energy Storage will be presented by Jeff Altizer, with Skaff Engineering Company.

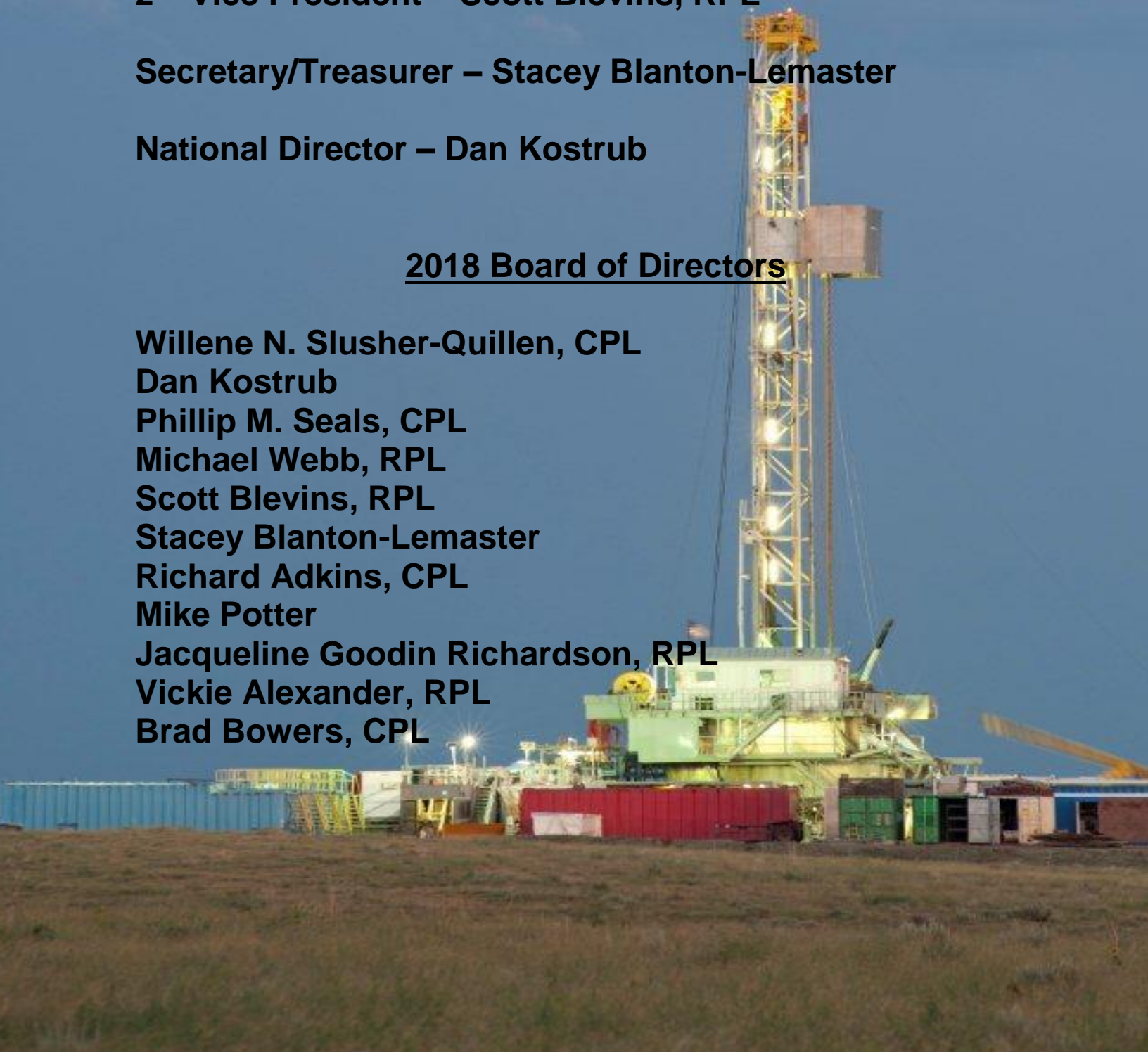
