- 2. Gene Christian performed invocation.

- The board discussed the five proposals that were submitted for Accounting Audit Services for Hospital District's FY 2016 and examined their experience levels and discussed the best fit for the hospital district.
- Consideration of audit firms. Sarah spoke on behalf of the finance committee to recommend using Condley and Company. Motion to select Condley and Company to provide audit services for Hospital District's FY 2016 by Sarah Beal and second by Ken Gifford. Motion carried.
- 6. Consideration of new administrative assistant. Patricia Barnett has been selected for consideration of the board to fulfill administrative assistant and bookkeeping services for the CCMC District. This is subject to performance and bond issuance. - 8. Melissa Ereman RN, DON gave CNO report. She gave report on the Santa's Helpers program in December 2016. 248 children received gifts through this program. About 3,000 gifts were distributed to the community in 3 hours on 12/22/16 with the help of the Coleman Police Dept., Coleman Fire Dept., HOT EMS, and Coleman Sheriff's Dept. CNA class is starting in March. Every student in previous classes found jobs in the field before graduating from the class. The Quality Assurance Project for 2017 is 'Safety'. Nurses have been continuing to take training courses to keep all licenses, credentials, and skills up to date.
- Dr. Horner, Chief of Staff, gave Medical Staff report. Dr. Thompson, ENT Specialist, has been coming from Abilene to Coleman Medical Associates to serve Coleman County. Dr. Swarna continues to stay busy.
