Historians Corner

GERALD MIZE - his story (part one)

Gerald was kind enough to give in to my persistent requests to have me tell his story of his time in the Marine Corps.

Gerald was born in Detroit in 1940, and grew up in East Detroit on Rausch Street attending East Detroit High School.

Not too long after completing high school, he joins the Marines for four years.

He left for San Diego for out of Willow Run airport Friday August 28th 1959. (Metro Airport was still under construction at that time. He arrived on a foggy morning, picked up by bus and taken to a diner in town for breakfast. He then was taken to receiving barracks to be processed, but since he arrived on weekend he ended up staying there for two days. But then came Monday and the S*** hit the fan. (I asked if there were the famous "yellow footprints" and Gerald says there were none in 1959). He was assigned to recruit platoon 265. Like today, boot camp was 13 weeks long.



As we all remember, a recruit was forbidden to receive any packages from home, and Gerald recalled an incident where a recruit received a box of fudge. So the D.I. has this recruit get a canteen of warm water and eat this box of fudge and wash it down with the warm

water. The result of this was not pleasant at all for the recruit.

Another incident involved two recruits smoking cigarettes while hiding in a trash dumpster. Of course they were caught by the D.I., and then were told to fill their mouths with cigarettes, light them up, and then smoke them while having a bucket over their head.

Like many of the "old breed" Gerald went to Camp Matthews for the rifle range. In his case he took a bus there and then marched back after rifle qualification. While there they lived in tents. While at the range a rash of food poisoning occurred, and a number of recruits became seriously ill. Gerald was lucky and did not get sick. His previous experience working in a restaurant taught him what foods to avoid. Gerald qualified as marksman on the M-1 and sharpshooter on the .45 pistol.

After graduation he was given 10 days leave. The trouble was there was no travel time allotted for getting home. You had to use part of your 10 days to get home! The bad thing for Gerald was he had to take a train home. As he tells it, most of those 10 days were spent on trains coming and going. He recalls he might have spent 4-5 days at home at the most. When he got back to the west coast he reported to Camp Pendleton for ITR (Infantry training regiment).

Upon completing ITR, Gerald reported to weapons platoon, Company "A", 1st battalion 7th marines on January 8th 1960 at Camp Pendleton.



In March the battalion set sail for Westpac duty on the USS General Mitchell, stopping in Hawaii, crossing the International Date Line, stopping in Japan, and finally arriving in Okinawa. Once situated in Okinawa, the battalion was redesignated as 1st battalion, 9th Marines, 3rd Marine Division. Gerald's MOS was 0351 (antitank/assault).

During his time on Okinawa, his unit participated many amphibious in training exercises via landing craft or helicopter, doing all of the things typical of a Marine infantryman. This training was conducted throughout the western Pacific - the Philippines, Japan, South Korea, with R&R visits to Hong Kong and Hawaii. There home base was Camp Hansen. His unit was stationed adjacent to elements of the 82nd Airborne Division and Gerald recalls participating in some of the training that the 82nd conducted, but he never did have to jump out of a plane!
