

# **Licensed Therapist (LMHC/LCSW)**

### ROLES AND RESPONSIBILITIES: THERAPIST

Under the direction of the Chief Executive Officer (CEO) and Chief Medical Officer (CMO) and in close collaboration with the Vice President of Network Operations, the Counselor/Therapist provides psychosocial support, behavioral health assessment, individual and small group therapies for chemically dependent patients and/or their families. This role will be a key position within a multi-disciplinary treatment team, and they will maintain a defined caseload, develop treatment plans, lead educational groups, and provide timely and accurate documentation. The Counselor/Therapist also ensures that clinical programs and business expectations across multiple customer teams are managed based upon standard policies and procedures. Additionally he/she will ensure that staff members work collaboratively as a team, are focused on high-level clinical quality, and work efficiently and effectively to achieve established targets and goals, providing a positive, and seamless experience to the patients and organizations that the Company serves. The primary responsibilities are detailed below:

### **Substance Use Disorder Treatment**

Provides clinical review and evaluation of assigned patients with substance use disorders; must be familiar with the various levels of care available for those with substance use disorders

- Works with patients and their families to develop/advance their knowledge and understanding of their condition/disease as well as identifying achievable therapeutic goals
- 4 Teaches patients to utilize the tools necessary to maintain recovery and avoid relapse
- Contributes to and fosters an environment where our team of compassionate care providers effectively and collaboratively treat patients and keep them on the path to recovery
- 6 Treats patients in accordance with TRRN's protocols
- Provides expertise and input regarding the type, level of intensity and quality of care for patients
- 8 Ensures compliance with HIPAA and efficiently completes accurate patient documentation
- 9 Reports to departmental director and CEO and executes expanded functions as requested.
