Coordinate with classroom teachers, other educators and parents by providing suggested activities to enhance the student's educational progress and performance. 4. Maintain all required records, forms and files including those prescribed by the program and those required by the BOCES. Attend IEP meetings. 5. Consult with parents regarding student needs/progress. 6. Construct, modify and maintain adaptive equipment for positioning, activities of daily living, vocational and classroom use. 7. Facilitate in-service education for districts; train and monitor teachers and paraprofessionals to assist in the maintenance of motor objectives. 8. Participate on BOCES teams to provide expertise about motor intervention.
